



CARES ACT REPORTING ON EMERGENCY FINANCIAL AID GRANTS TO STUDENTS

On December 27, 2020, the Coronavirus Response and Relief Supplemental Appropriation Act (CRRSAA), Pub. L. No. 116-260 was signed into law for education through the Coronavirus Aid, Recovery, and Economic Security (CARES Act). The CARES Act authorized the Higher Education Emergency Relief Fund which provides emergency funding for student and institutions impacted by the COVID-19 pandemic also known as HEERF II. To make Emergency Financial Aid Grants to students for expenses related to the disruption of campus operations due to coronavirus, including eligible expenses under the student's Cost of Attendance, such as food, housing, course materials, technology, health care and childcare. The law requires institutions to report certain information related to the use of these funds. The following information is reported for the period June 1, 2021-August 31, 2021.

- I. This statement shall serve to acknowledge that our institution signed and returned to the US Department of Education the *Certification and Agreement - Emergency Financial Aid Grants to Students*. We further attest that our institution has used, and/or intends to use, the initial drawdown was no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to Students.

 4. In an effort to assist ALL eligible students that were enrolled at Infinity College as of the day of the Coronavirus Response and Relief Supplemental Appropriation Act (CRRSAA) declaration, which is December 27, 2020 the MAXIMUM AWARD WILL BE APPROXIMATELY \$400.00. We intend to service approximately 116 students, PLUS Nursing Assistant Students.
 5. Students with an EFC score of zero (0-1000) will be eligible for the maximum award of approximately \$400.00.
 6. Students with an EFC score of greater than zero (1000) will be eligible for approximately \$300.00 which is 75% of the maximum award.
 7. Only eligible for active students in good academic standing.
 8. Once funds are near exhaustion the approximate maximum award could vary based on the availability of remaining funds.

On December 27, 2020, the Coronavirus Response and Relief Supplemental Appropriation Act (CRRSAA) was signed into law for education through the Coronavirus Aid, Recovery, and Economic Security (CARES Act). The CARES Act authorized the Higher Education Emergency Relief Fund which provides emergency funding for student and institutions impacted by the COVID-19 pandemic also known as HEERF II. On January 14, 2021, the US Secretary of Education announced that the student funding was being made available to institutions to award and disburse to students who have incurred expenses related to the disruption of campus operations due to coronavirus, including eligible expenses under the student's Cost of Attendance, such as food, housing, course materials, technology, health care and childcare.

In order for these emergency grants to be awarded without regard for the provision under the CARES Act that required awards to students who are or could be eligible to participate in the Department's Title IV Federal student financial aid programs under HEA Section 484. In other



words, the institution is NOT required to have either a valid ISIR or an attestation from the student to support Title IV eligibility. Financial Aid Grants to be awarded to students exclusively enrolled in distant education. At this time, International students, DACA students and undocumented noncitizens continue to be INELIGIBLE.

HEERF II prioritize grants to students with exceptional need, such as students who receive Pell Grants. However, students do not need to be Pell recipients or students who are eligible for Pell grants in order to receive a financial aid grant.

The students may apply the financial aid grant to the student's outstanding account balance with the institution, provided it has obtained the student's written (or electronic), affirmative consent. Students are NOT REQUIRED to use these funds for tuition, fees and/or other direct institutional costs; this is strictly an option.

Under the authorized by the American Rescue Plan (ARP), Public Law 117-2

On March 11, 2021, President Biden signed the American Rescue Plan Act of 2021 (ARP) (Pub. L. 117-2). The ARP appropriated approximately \$39.6 billion for the Higher Education Emergency Relief Fund (HEERF III) and represents the third stream of funding appropriated for HEERF (III) to prevent, prepare for, and respond to coronavirus. Taken together, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) (Pub. L. 116–136), the Coronavirus Response and



Relief Supplemental Appropriations Act, 2021 (CRRSAA) (Pub. L. 116-260), and the ARP represent HEERF I, HEERF II, and HEERF III, respectively.

The American Rescue Plan Act authorized the Higher Education Emergency Relief Fund (HEERF III) which provides emergency funding for student and institutions impacted by the COVID-19 pandemic also known as HEERF III. The US Secretary of Education announced that the student funding was being made available to institutions to award and disburse to students who have incurred expenses related to the disruption of campus operations due to coronavirus, including eligible expenses under the student's Cost of Attendance, such as food, housing, course materials, technology, health care and childcare.

In order for these emergency grants to be awarded without regard for the provision under the American Rescue Plan Act on student eligibility for HEERF III states that all students who are or were enrolled in an institution of higher education during the COVID-19 national emergency are eligible for emergency financial aid grants from the HEERF III, regardless of whether they completed a FAFSA or are eligible for Title IV. That includes citizens, permanent residents, refugees, asylum seekers, Deferred Action for Childhood Arrival (DACA) recipients, other DREAMers, and similar undocumented students.

HEERF III prioritize grants to students who are or were enrolled in an institution of higher education on or after the date of the declaration of the national emergency due to the coronavirus (March 13, 2020) are eligible for emergency financial aid grants from the HEERF III, regardless of whether they completed a FAFSA or are eligible for Title IV. The CRRSAA requires that institutions prioritize students with *exceptional* need, such as students who receive Pell Grants or are undergraduates with extraordinary financial circumstances, in awarding emergency financial aid grants to students.

Beyond Pell eligibility, other types of *exceptional* need could include students who may be eligible for other federal or state need-based aid or have faced significant unexpected expenses either for themselves or that would affect their financial circumstances, such as the loss of employment, reduced income, or food or housing insecurity.



In addition, the CRRSAA and ARP explicitly state that emergency financial aid grants to students may be provided to students exclusively enrolled in distance education provided the institution prioritizes exceptional need. The Department encourages institutions to prioritize domestic students, especially undergraduates, in allocating this funding. Domestic students include citizens, permanent residents, refugees, asylum seekers, DACA recipients, other DREAMers, and similar undocumented students.

The students may apply the financial aid grant to the student's outstanding account balance with the institution, provided it has obtained the student's written (or electronic), affirmative consent. Students are NOT REQUIRED to use these funds for tuition, fees and/or other direct institutional costs; this is strictly an option.
