### SB 189 — Workers' Compensation Insurance for Physicians

This COA-supported bill clarifies legislation that passed last year that required physicians, with less than a 15 percent ownership interest in their medical corporation, to purchase Workers' Compensation insurance. SB 189 creates an exemption for physicians who are an owner of a professional corporation rendering the professional services for which the professional corporation was organized and who signs a waiver of coverage and confirms that they are covered by a health insurance policy. The bill would be effective July 1,

2018. Passage of this bill will save orthopaedic groups thousands of dollars in Workers' Compensation premiums. The bill is on the Governor's desk awaiting his consideration.

## Maximus gets it wrong in 99358 IBR decision

Maximus Federal Services, the arbiter of Independent Bill Review for the California Division of Workers' Compensation, has denied payment to a provider due to a an error on Maximus' own part. The mistake, based on an outdated status code designation for CPT codes 99358 and 99359, is one DaisyBill anticipated. With Maximus behind the curve on changes to the Official Medical Fee Schedule effective this year, other providers may be in danger of the similar mistreatment. [READ MORE](#)

## Joint Commission introduces new accreditation standards for telehealth services

The Joint Commission has proposed changes to its accreditation standards to account for direct-to-patient telehealth services. The new standards will apply to Joint Commission-accredited hospitals and ambulatory health care organizations offering direct-to-patient telehealth services. Accredited hospitals and organizations, as well as entrepreneurial telemedicine companies that contract with such hospitals, should be mindful of these proposed rule changes and how they will affect their telehealth services and operations.
