Position Overview

The Licensed Behavioral Health Therapist will provide direct therapy and case management services to clients in the community, at schools and the community center.

Responsibilities:

Perform the following from a racial, gender, sexuality, and ability equity lens:

- Average a number of billable hours of direct service per week as directed by supervisor in workplan.
- Perform a variety of therapy, assessment, and case management services.
- Provide assessment, treatment, and training services at community locations/schools, as requested.
- Conduct therapeutic groups on a variety of topics as needed.
- Participate in an interdisciplinary team within the school or other community locations regarding social emotional needs of students.
- Maintain complete, accurate, and timely written documentation in client files of all services provided.
- Participate in all- agency meetings, behavioral health staffings, and supervision.
- Demonstrate knowledge of Alternatives, Inc. policies, practices, and services.
- Demonstrate a commitment to Positive Youth Development, Restorative Justice and Trauma Informed practices.
- Complete in a timely fashion all other tasks as assigned by the Behavioral Health Supervisor.

Qualifications:

2. Clinical licensure in field of Study Preferred (LCSW, LCPC)
3. Spanish speaking preferred
4. Past experience working with youth.
5. Knowledge of adolescent/family dynamics, substance abuse and trauma issues.
6. Cultural competency with Black/Latinx and LGBTQ+ youth.
7. Interest and commitment to working in a community-based youth service agency.
