IT IS ORDERED:


The Receiver's Petition No. 28 seeking approval of a limited return of excess premium is approved.

The Receiver is authorized to refund the excess premiums to the members in the amounts specified therein, including with respect to MHP, excess premiums paid by 115 members totaling \$24,231.31, and with respect to Meritus Mutual, excess premiums paid by 15 members in the total amount of \$7,894.54.

The Receiver is authorized to make similar refunds of excess premiums without further order of the Court if additional circumstances warrant so long as the aggregate amount of additional refunds does not exceed \$5,000, combined.

The Receiver is authorized to take such further actions as are necessary and appropriate to implement this Order.
