 - Mailing Report: (Rich N & Curtis B) The April mailing went out Thursday, April 28 to 102 addresses. - ABM Delegates NEI ability to send second delegate. Can't afford to send a second delegate. What happens to the delegate funds raised so far? **Motion to send one delegate only (Patrick/Rosanne): 6-0-0.**

New Business

- Spring Gathering Survey Results Overall, evaluations were good. Some issues with Healthy Relationships session There were some negative comments. Suggestion that we use Northeastern: We may be able to use a room for free.
- Sobriety requirement to be NEI representative The requirement for voting is 3 months sobriety, but a group can elect a representative who doesn't meet the requirement. If there are fewer than 5 elected representatives with less than 3 months continuous sobriety, someone can make a motion to allow the elected representatives with less than 3 months sobriety to vote. From the NEI Bylaws:
 - O Article III Section B: Each GR and AR shall have at least three months continuous sobriety in S.L.A.A. Groups without members willing to serve that have at least three months of continuous sobriety in S.L.A.A. may choose to elect a provisional representative to serve on behalf of the GR and AR. Probationary GRs and ARs will become voting GRs and ARs once they have obtained the required sobriety. Each GR and AR is required to have three months of concurrent affiliation with the group the delegate wishes to represent. In the case of a meeting younger than three months, the concurrent affiliation requirement shall be waived.
 - O Article V Section A: At a S.L.A.A. New England Intergroup business meeting held upon proper notification, those GRs and ARs present shall constitute a quorum and a simple majority of those present shall govern for voting purposes. Quorum will only include voting GRs and ARs excluding any provisional GRs and ARs unless 2 criteria are met. 1) the number of voting GRs and ARs present at the meeting is less than 5 and 2) a vote of those voting GRs and ARs indicates a group conscience to allow provisional GRs and ARs to vote at that meeting.
