The deadline to submit the proof with the class administrator is September 15, 2017. The class action administrator for this case is Strategic Claims Services. The lawsuit was originally filed in the U.S. District Court for the Southern District of New York over alleged violations of Federal Securities Laws by Code Rebel in connection with certain allegedly false and misleading statements made between August 17, 2015 and May 5, 2016. According to the complaint the plaintiff alleges on behalf of purchasers of Code Rebel Corp (NASDAQ: CDRB) common shares between August 17, 2015 and May 5, 2016, that the defendants violated Federal Securities Laws. More specifically, the plaintiff claims that between August 17, 2015 and May 5, 2016, the defendants issued allegedly false and misleading statements to investors and/or failed to disclose that Code Rebel Corp's financial statements contained errors concerning its assets and financial condition, and that as a result of the foregoing, Code Rebel Corp's public statements were materially false and misleading and/or lacked a reasonable basis at all relevant times.
