One of the joys of preparing an annual report is that it gives us a chance to look back and to be thankful for all that has been accomplished. The past year was filled with many opportunities to make a difference in the lives of local women. Some highlights were:

- Women2Women has given financial aid to local women who have exhausted all other resources in the community for emergencies, such as car repairs, dentures, hearing aids, deposits, and educational assistance.
- In 2019, Women to Women assisted 244 local women with \$159,000.
- Women2Women has increased our partner agency network to approximately 60 agencies.
