CALL FOR ENTRIES

This is the 32nd annual call for entries to the Cinco Banderas (Five Flags) Competition Exhibition. Works from this annual juried exhibition are purchased for the Collection – a unique and permanent body of work consisting exclusively of regionally produced art. All Northwest Florida artists are eligible to enter.

ABOUT THE COLLECTION

The Cinco Banderas Collection was conceived and founded in 1988 through the generosity of the Kobacker Foundation. The permanent collection is currently exhibited at the downtown Pensacola Library. CRITERIA FOR SELECTION

Each applicant may submit up to two pieces of art, created within the last two years. The Cinco Banderas juror will be looking for works of high artistic quality, competence in execution, and a strong personal vision. Finalists will be juried from all submitted entries. All finalist selections must be for sale.

- A 25% commission will be charged on all sales other than the Cinco Banderas purchase selections.
- A completed entry form available at the gallery or at www.artelgallery.org must accompany all entries.
- The competition is not limited to any medium, but due to the nature of the collection, installations and video works are not encouraged.
- Works previously exhibited in Cinco Banderas are not allowed.
- Late entries will not be accepted.
- All artists must sign the entry form attesting to residency in Northwest Florida.

While every precaution will be taken to ensure safe handling, Artel Gallery shall not be liable for accidental damage. Submission to this competition constitutes agreement with competition rules. Artel Gallery reserves the right to use photographs of the exhibit or individual pieces on its web site, in grant applications or in publicity.

The entry fee is \$35. Artworks should be delivered ready for display, including pedestals for 3-D works, to Artel Gallery, 223 Palafox Place, on the following days: Friday, October 23, 10 am to 4 pm and Saturday, October 24, 10 am to 1 pm. Works not selected for exhibition must be retrieved during normal Gallery hours on Tuesday, October 27, 10 am to 4 pm. Artists whose work has been selected will be notified on the evening of Saturday, October 24.

The 32nd Annual Cinco Banderas Exhibition will open on Tuesday, October 27, at Artel Gallery, and will remain on view through Thursday, December 3. Work should be picked up on Friday, December 4, 10am - 4pm

THE JUROR

Susan Nomberg McCollough

Susan Nomberg McCollough was selected in Florence, Italy where she traveled to receive "Artist of the Year" in 2017 by Art Tour International Magazine and was selected as one of the Top 60 Masters of Contemporary Art. She also earned the title of Best Modern/Contemporary Artist of 2015/2016/2017. McCollough was born in Bronx, New York; grew up in Dothan, Alabama; and graduated from Dothan High School.

She received her B.S. in Theater and Art from The University of Alabama studying with Alvin C. Sella,

Frank Engel, Max Hellman and later continued to study with many accomplished artists and teachers, including Professor Gary Sussman at Students Arts League of New York, Vytlačil Campus (sculpture) and Sonia De Franceschi at the Accademia D'Arte in Florence, Italy "(Old Masters technique of painting and gold leafing)".

Most days you will find her working in the studio, where she welcomes all visitors. It is located next to the Villas at the McCollough Institute. The Institute is located at 350 Cypress Bend Blvd., Gulf Shores, Alabama 36542.
