#### SECTION 4. FIRST-AID MEASURES

##### First-aid Measures

###### Inhalation

Move to fresh air. Keep at rest in a position comfortable for breathing. If breathing has stopped, trained personnel should begin rescue breathing. Seek immediate medical attention.

###### Skin Contact

Quickly and gently blot or brush away excess chemical. Take off immediately contaminated clothing, shoes and leather goods (e.g. watchbands, belts). Immediately wash gently and thoroughly with lukewarm, gently flowing

water and mild soap for 15-20 minutes. Seek medical attention if irritation develops or persists.

#### **Eye Contact**

Quickly and gently blot or brush chemical off the face. Immediately rinse the contaminated eye(s) with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. Seek medical attention if irritation develops or persists.

#### **Ingestion**

Rinse mouth with water. Never give anything by mouth if victim is rapidly losing consciousness, or is unconscious or convulsing. Do not induce vomiting. Seek medical attention.

#### **Most Important Symptoms and Effects, Acute and Delayed**

If in eyes:

Causes moderate to severe irritation. Symptoms include sore, red eyes, and tearing.

Can irritate the mouth, throat and stomach. Symptoms may include nausea, vomiting, stomach cramps and diarrhea.

### **Personal Precautions, Protective Equipment, and Emergency Procedures**

Handle in accordance with good industrial hygiene and safety practice. Shut off all ignition sources. No flares, smoking or flames in hazard area. Provide adequate ventilation.

### **Environmental Precautions**

Do not allow into any sewer, on the ground or into any waterway. If the spill is inside a building, prevent product from entering drains, ventilation systems and confined areas.

### **Methods and Materials for Containment and Cleaning Up**

Stop or reduce leak if safe to do so. Contain and soak up spill with absorbent that does not react with spilled product. Contaminated absorbent poses the same hazard as the spilled product. Place used absorbent into suitable, covered, labelled containers for disposal. After cleaning, flush away traces with water collect washing for disposal.

### **Precautions for Safe Handling**
