STEP 1:

CHOOSE A BUSINESS STRUCTURE:

Choosing the best business structure for your business can be difficult. Work with a local attorney to figure out what structure is best for your business.

MARKET RESEARCH:

Dive deeper and get specific about your intended products and/or services.



STEP 2:

TIME TO TAKE ACTION!

WORK WITH LOCAL BANKER:

As you move forward, you will want to work with your local banker to determine how much financing you qualify for. BCDA staff will then work with you to determine if there are any assistance programs, gap-financing, or loan programs that you may qualify for.

FIND A LOCATION:

You've created a business plan and have identified your business needs, now, let's find a location.

ORGANIZATIONAL PLAN:

Develop a plan to keep your financials organized and fulfill tax responsibilities.

HIRE AND DOCUMENT EMPLOYEES:

Develop a hiring process, business policies, and work with a CPA to determine what new hire paperwork is needed, and what fees may be associated with employees.

MARKETING AND ADVERTISING PLAN:

Develop a plan of action for the launch/opening of your business and for the years to come. We know that marketing/advertising is difficult to keep up with, but don't worry! BCDA will connect you with free resources to assist you.
