Motion by Chair Olson to keep the township board meetings the last Tuesday of the month @ 7:30 pm, second by Supervisor Schlaeger, motion carried unanimously.

Motion by Supervisor Schlaeger to set the December meeting date for December 13, 2016, second by Chair Olson, motion carried unanimously.

Motion by Chair Olson to set the Annual Road Inspection for same date as the Board of Equalization, second by Supervisor Schlaeger, motion carried unanimously.

Motion by Supervisor Pearson to appoint Chair Olson as the Road Supervisor for 2016, second by Supervisor Schlaeger, motion carried unanimously

Motion by Chair Olson for the Township Bank to remain Frandsen Bank and Trust at Pine City, second by Supervisor Schlaeger, motion carried unanimously.
