

# OATH OF AFFILIATION OF POLITICAL PARTY

**“I swear or affirm that I have not voted, and I will not vote, in a Primary Election or participate in a convention of another Party during this voting year. I hereby affiliate myself with the Republican Party.”**

Pursuant to Rule 25 of the Rules of the Republican Party of Texas and the Texas Election Code, Sec. 162.007 (b), by signing this oath I become ineligible to vote in a Primary Election or participate in a convention of another Party, including a Party not holding a Primary Election, during the voting year in which this Primary Election is held.

Texas Election Code, Sec. 162.008 (b). On request of a person desiring to affiliate with a Political Party, a member of the County Executive Committee for the county in which the person resides shall administer the oath prescribed by Sec. 162.007 (b).

Texas Election Code, Sec. 162.011. (a). A person commits an offense if for the purpose of participating in a political party's convention the person presents to a party official: (1) an affiliation certificate that the person knows was not issued in compliance with this chapter; or (2) a voter certificate with a party affiliation stamp that the person know was not obtained in compliance with this chapter. (b) An offense under this section is a Class C misdemeanor.

Texas Election Code, Sec. 162.014. (a). A person commits an offense if the person knowingly votes or attempts to vote in a Primary Election or participates or attempts to participate in a convention of a Party after having voted in a Primary Election or participated in a convention of another Party during the same voting year. (b) An offense under this section is a Class C misdemeanor.
