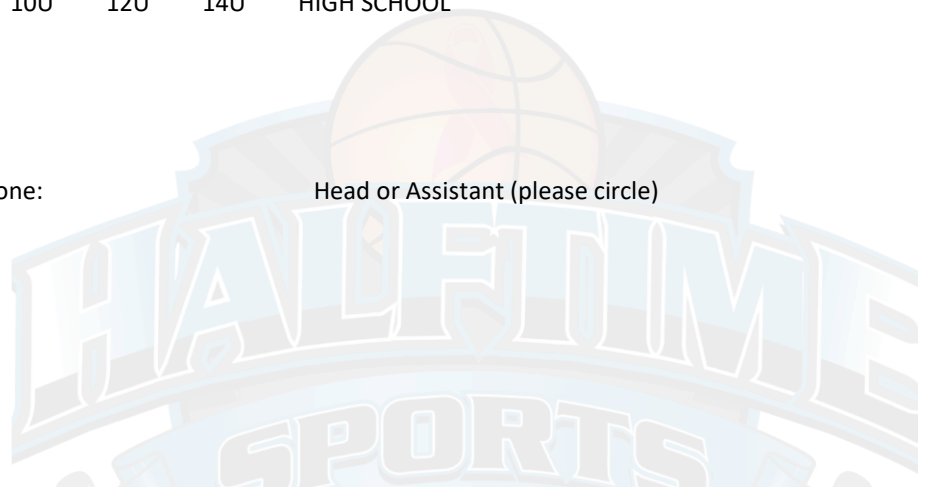

As a volunteer coach, I AGREE TO:

- Treat each player as an individual, remembering the large range of emotional and physical development for the same age group. I will treat each player, opposing coach, official, parent and program supervisor with respect and dignity.
- Become familiar with the rules and objectives of the Youth Sports Program with which I am affiliated. I will strive to achieve these objectives and communicate them to my players, their parents and friends.
- Conduct my practices and games in a way that provides all players an opportunity to safely improve their skill level through active participation and lead by example in demonstrating fair play and sportsmanship to all my players.
- Uphold the authority of officials who are assigned to games and to assist them in conducting fair and impartial games. I will cooperate with the administrators of our organization in the enforcement of rules, regulations and program philosophy, and will report any irregularities that violate sound competitive or ethical practices or situations which may be deemed questionable or not in the best interest of the participants.
- Provide a sports environment for my team that is free of drugs, tobacco, and alcohol, and to refrain from their use at all youth sports events.
- Refrain from striking, slapping, shaking or harming any participant nor tolerate it on the part of anyone involved in practices or games.
- Use City of Milton facilities properly and leave them in the same or better condition than I found them, and to return all equipment provided at the end of the season and to report any defective equipment immediately. Remember that I am
- a youth sports coach, and that
- the game is for children and not adults. I will place the emotional and physical well-being of my players ahead of my personal desire to win.

I have read the rules and regulations and understand my responsibilities as a volunteer coach. I understand that the City of Milton/Halftime Sports may terminate my volunteer services as coach for any violation of the City of Milton/Halftime Sports rules and regulations, and the philosophy contained in the coach's manual. I also understand that my volunteer services may be terminated at any time by the City of Milton/Halftime Sports without cause and without notice.
