The August 13, 2014 Town of Oulu regular board meeting was called to order at 6:31 p.m. at the Town Hall by Chair Sandra Rantala.

Roll Call: Members present: Terry Egbert, Sandra Rantala, Duane Reijo, Diana Reijo, clerk, Marjorie Lahti, treasurer. Absent and excused: None. Town employee: Jonathan Nelson.

Consent Agenda: Motion by D. Reijo, second by T. Egbert to approve the consent agenda:

- Minutes of the July 16, 2014 regular board meeting

Motion carried unanimously by voice vote.

Treasurer's Report: General Fund \$ 96,836.27 and Tax Account \$ 34,005.19.

Plan Commission Report: S. Rantala

Plan Commission reviewed and updated nine of the eleven elements of the Comprehensive Plan.

Cemetery/Park Report: T. Egbert

Cemetery and park both need mowing.

New Business:

Propane Contract: Motion by D. Reijo, second by T. Egbert to contract with Midland Services, Inc. with the budget plan for 3,000 gallons of propane at \$1.72/gallon paying an additional cost of \$.10 per gallon non-refundable retainer fee. Motion carried unanimously by voice vote.

Snowplowing Rates: Motion by T. Egbert, second by D. Reijo to set the 2014-15 snowplowing rate for driveways at \$100 if paid prior to October 31<sup>st</sup> and \$125 if paid after November 1<sup>st</sup>. Motion carried unanimously by voice vote. Language added to the snowplowing contract include: Driveways with gates must be accessible at all times. If gates are closed snowplowing driveways will be done with the next regular driveway snowplowing. No special trips will be made.
