The August 19, 2017 Town of Oulu regular board meeting was called to order at 8:00 a.m. at the Town Hall by Chair Sandra Rantala.

Roll call:

Approval of agenda:

New Business:

Snowplowing Regulations: No changes were made to the snowplowing regulations. Notices will be mailed in September. Employees need to submit a list of driveways that need to meet the snowplowing requirements in order for their driveways to be snowplowed.

Airport Road Project: Motion by Hamilton to put Airport Road project out on bids. Discussion followed. Hamilton withdrew his motion. Tabled until additional information is received.

Oulu Pioneer Memorial Park Water Samples Report:

A report was received from Anne-Marie Coy, Laboratory Manager, Bayfield County Health Department indicating the coliform bacteria test result is safe and the nitrate level is below the maximum contamination, and that no further action is required this year.

Cemetery/Park/Landfill/Road Maintenance Report:

- The outhouses at the park have been pumped.
- All the park grounds need to be mowed and trimmed along with the staining of the dugouts and pavilion.
- Cemetery needs to be mowed and trimmed around the headstones
- Town hall needs mowing and trimming around the building.
- Mowing and trimming needs to be done by the gas tanks by the garage.

- Intersection sign has been put up.
- When mowing roadsides, employees need to slow down to cut the grass.
- Culvert was installed on south Hoover Line Road.
