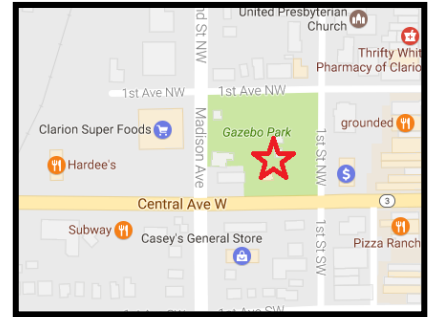

Vendor fees will be used to cover trash, toilets & electric costs.

Bikers will be traveling to Clarion from Eldora. We expect to start seeing the first riders in Clarion around **Noon and that will continue through 6pm**. Due to the variance in arrival time, we are allowing you to choose a time frame for set-up and food service. Please see options on the back side of this form.

The street will be closed off by 8am on Wednesday.

Rules & Regulations

Vendor Restrictions

- **Allowed:** Food and beverages including alcohol, pre-approved by the Iowa's Ride-Clarion committee.
- **Not Allowed:** Repeat food items, in order to provide a good variety for the riders. Iowa's Ride-Clarion committee will be reviewing applications upon receipt and will notify of approval.
- **First Right:** Wright County vendors have first right to register. First right registrations must be submitted by April 15th, 2020, then spots will open up to out-of-county vendors. Out-of-county vendor applications will not be reviewed or approved until after the first right deadline. In general, you should receive a response within 7-10 business days.

Payment & Taxes

- Payment for space must be received in advance or your spot will be forfeited.
- No refunds or cancellations for any reason including weather.
- **Vendors must receive a valid, temporary food license from the State of Iowa to participate. Proof of license will be required.**
- **If serving alcohol, vendors must have a valid, alcohol license from the State of Iowa to participate. Proof of license will be required.**
- It is the responsibility of the vendor to collect Iowa state sales tax and to remit to the Iowa Department of Revenue and Finance.

Set-up & Tear Down

- Vendors must be present and set up during all hours that you indicate on the back of this form. No early tear downs, unless pre-approved by the Iowa's Ride-Clarion committee. Vehicles must be removed from the area immediately after set-up. Tear down is immediately following this event at 8pm. However, if traffic is still good, please feel free to stay set-up until 9pm.
- All canopies, tables, chairs, and display materials will be provided by the vendor.
- Vehicles are only allowed in the barricaded area for unloading/loading during set-up and tear down. Otherwise, vehicles need to be parked legally elsewhere.

Risk & Liability

- The City of Clarion, Iowa's Ride-Clarion committee, Clarion Chamber & Development, its agents, employees, and affiliates assume no risk and shall not be responsible for any damage, injury, loss, legal action, or expenses that may arise or come to the exhibitor or his employee, or his goods or property, or to the public from any cause whatsoever. Exhibitor understands that he should carry business/personal liability insurance.
- Iowa's Ride-Clarion committee has the right to refuse any and all vendor applications.
