Open Discussion

- Locator overload, Across the state it is being a concern about the number of locate tickets being submitted and the locators ability to get all utilities marked within the 72 hour window,
- The fiber projects are creating a lot of the number of tickets,
- Concerns with some locate company's using code 32 (Not enough Information) as a way to clear that locate request,
- Concerns with Locators asking for 48 hour extension to 72 Hour notice,

Reports

- **NCDOT** – Steve Trexler-NCDOT is outsourcing some of the design work and drawings to private engineering firms to help meet the work load and demands, NCDOT is rewriting the procedures manual. Encroachments are coming in higher than over last 12 Months,
- **NC811**- Mark Schuman Year to Date end of June 2015 733,539 increase of 14.2%, The Month of June was 145,038 25.5% increase over last year, Some increase could be contributed to education, DOT offices are currently training on RTE & planning on start dates as Member, Blood Drive will be held at 811 center in Greensboro, August 10th, August 11th is 811 day, 811 is working with Ingles grocery store & Van Wingerden to have 811 stickers on all they plants sold sent to each store in 6 states, Approx. 45,000 spring and hanging baskets, Howard Corey is doing training at community colleges, Warren Wilson College has a work study program, Approx. 40 811 billboards across the state
- **Excavator/Contractors**- Tim Yarbrow reported that Ansco is very busy. Discussed the need to have locate request completed within 72 hours, Discussion about proper job planning and making sure work is being scheduled with no resubmits if possible to help balance out locator concerns,
- **Gas Companies and Gas Pipelines** – Teresa VonCannon reported that Google had started coming to some local UCC meetings,
- **Oil & Oil Pipelines**—Tom West reported that several projects they were working on have been completed, Greensboro Urban loop, Skeet Club Road, High Point road Widening & Fleming Road Greensboro, Colonial will be working on side trimming in the Reidsville area approx. 330 miles of ROW to be mowed with some subdivision work in the Apex area.
