## Wheelchairs to El Salvador



**Don Manley** gave us a slide show report of the "Wheelchair" trip to El Salvador. There were 48 people in the group. Many were Rotarians and family members from our club.

Don explained that the idea started 3 years ago when his son, Hector, said he wanted to kayak the length of the Mississippi River as a fund raiser for the Wheelchair Foundation and the Wounded Warriors.

Last summer, after Hector graduated from the Univ. of Tampa, they set out with Don and Hector paddling in kayaks and Karen providing support from their boat.

When they got to the Mississippi they found it was the middle of a 50 year drought. At Memphis, the river was 62 feet below the prior year's level. For 10 days they kayaked in temperatures of more than 100°.

The trip raised \$75,000. The Wheelchair Foundation's portion was enough to pay for a container of 280 wheelchairs. These chairs were delivered to El Salvador two weeks ago.

Don and Sandy described some of the touching experiences during the visit. Don said, **"It truly was the greatest day of my life, the greatest trip I've ever had."**
