PRETRIAL CONFERENCE

Parties are hereby notified to set all other business aside and to appear in the courtroom of Judge Kimberly K. Anderson, located in Courtroom 2A at the DeKalb County Courthouse, 556 N. McDonough Street, Decatur, Georgia 30030.

The parties are reminded to review the Court's **Standing Order** as they prepare the proposed Consolidated Pre-Trial Order and in anticipation of their attendance at the Pre-Trial Conference.

**Parties must submit a CONSOLIDATED Pretrial Order by May 26, 2020**, in conformity with Uniform State Court Rule 7.2. Failure to respond to this calendar, or to file the proposed Consolidated Pretrial Order, may result in the parties and/or their counsel being held in **CONTEMPT** and/or in the **DISMISSAL** of the complaint, answer, counterclaim, cross claim or third-party claim, as appropriate.

All Motions in Limine shall be filed according to the deadline set forth in the governing scheduling order.

The **removal** of a case from the Pre-Trial conference calendar for any reason shall **ONLY BE BY ORDER OF THE COURT AND ANY REQUEST MUST BE FILED WITH THE COURT BY MAY 26, 2020.** A Motion for Continuance must be by consent of all parties and a **Consent Order** submitted, at the same time as the Motion is filed with the Clerk of the Court.

**Lead Counsel** is required to be present at the Mandatory Pretrial Conference on **June 2, 2020 at 9:00a.m.** Depending on the status of the judicial emergency and the health emergency created by Covid-19, this calendar may be held via Zoom as opposed to in-person. The Court will notify the parties at least one week prior to the calendar of any specialized procedures. In preparation for the pretrial conference Parties are directed to:

- Bring a **printed copy** of the Consolidated Pretrial Order for the Court;
- Discuss settlement options **prior** to the Pretrial Conference and be ready to discuss settlement history with the Court;
- Discuss any motions *in limine* that have been filed and make a good faith effort to resolve them; and
- Discuss any objections in depositions to be presented at trial and make a good faith effort to resolve them. **All unresolved objections, together with argument and citations, shall be brought to the pre-trial conference, with a copy to the Court.** Any objections not brought before the Court prior to trial shall be deemed waived.
