ATTORNEYS WHO WILL TRY THE CASE AND PARTIES REPRESENTING THEMSELVES ARE REQUIRED TO ATTEND THE PRETRIAL CONFERENCE ON THE ASSIGNED DATE AND TIME.

NO CONTINUANCES WILL BE GRANTED EXCEPT ON PRIOR ORDER OF THE COURT FOR LEGAL CAUSE SHOWN. THESE REQUESTS MUST BE IN WRITING AND RECEIVED IN THE STATE COURT CLERKS' OFFICE BY OCTOBER 21, 2020. All conflicts shall be handled as required by Georgia Uniform Rule 17.1.
