

The removal of any case from the trial calendar shall be by Order of the Court.

If any party objects to proceeding with a virtual hearing rather than in person, a written objection shall be e-filed no later than April 7, 2021. A party that does not object in writing shall be deemed to have consented to a virtual hearing.
