**ORDER OF INSTRUCTIONS FOR  
DIVISION VI CIVIL NON-JURY CALENDAR**

These cases are hereby placed upon the Court's Civil **Non-Jury Trial** Calendar scheduled for **May 19, 2021, at 10:00 a.m.** **All parties and counsel are required to be present via Zoom at the call of the calendar and are directed to contact the civil case manager, Summer Schmidt, by May 5, 2021, regarding further instruction and technology for the hearing.** Any evidentiary exhibits must be submitted via e-File at least 72 hours prior to the Hearing date. Any witnesses necessary for trial must be available via Zoom. Documentary evidence shall not be considered absent proper foundation for trial. The Court will not consider affidavits brought for trial, unless they comply with the provisions set forth in the 2013 Georgia Evidence Code.

ALL MOTIONS AND/OR DEMANDS shall be made in writing as separate pleadings. They shall be filed with the CLERK OF THE COURT and a copy served on the opposing party on or before twenty (20) calendar days prior to the trial date listed.

An Order of the Court is required to remove a case from the trial calendar. A Motion for Continuance will be considered only if consented to by all parties and a Consent Order is submitted. **If a motion for continuance is submitted less than 72 hours before the hearing, parties must email a courtesy copy of the motion and order to the Civil Case Manager, Summer Schmidt (skschmidt@dekalbcountyga.gov), or the motion will not be considered.** Failure of the Plaintiff to comply with the Court's direction will result in the complaint being dismissed without prejudice. Failure of the Defendant to comply with the Court's direction will result in any counterclaim/cross-claim/third party claim being dismissed without prejudice and the answer being stricken.

If the case is resolved in any manner, notify the civil case manager, **Summer Schmidt, at 404-687-7135 (skschmidt@dekalbcountyga.gov)** and follow up with a pleading confirming dismissal or settlement at least 72 hours before the scheduled hearing.
