Only after the Defendant attends the Compliance Hearing scheduled above.

At the Defendant's request, the Court is offering the option of performing community service for _____ **hours** as the sentence in this case. If the Defendant chooses the community service option, he or she must present to the Court at the Compliance Hearing a letter on official agency/organization letterhead signed by an administrator or supervisor stating the number of community service hours the Defendant performed for the agency or organization. If the Court accepts this documentation, the Court will impose these community service hours as the sentence in this case, and any fines or fees will be suspended.

***** Defendants who choose to perform community service must attend the Final Compliance Hearing scheduled above to present the Court with community service documentation. *****

The Defendant's **failure to appear** at the Compliance Hearing when required by this Order **may result in the probation provision of the Plea Order being enforced, along with a bench warrant for the Defendant's arrest and or suspension of the Defendant's driver's license.**
