In consideration of being permitted to visit the Maritime Center and/or participate in activities provided, sponsored, or promoted by the Port Royal Sound Foundation, I make this Agreement knowingly and voluntarily for myself and my spouse, heirs, legal representatives, insurers, successors, and assigns and/or as parent or guardian of the minor child(ren) named herein below, regarding all activities on the property of Port Royal Sound Foundation and/or provided, sponsored, or promoted by the Port Royal Sound Foundation (hereinafter referred collectively as "Activities").

**ASSUMPTION OF RISK.** I acknowledge that I and/or the minor child(ren) have VOLUNTARILY CHOSEN TO PARTICIPATE in Activities, and I understand that Port Royal Sound Foundation does not require participation in any Activities.

I understand that participating in Activities may be inherently dangerous and pose certain inherent, natural, and/or human-created dangers, both hidden and obvious, which present the risk of injury, including permanent disability and/or disfigurement, death and/or property damage. I acknowledge that water-based activities may pose a higher probability of injury and/or death due to hazards that differ from the hazards of other activities, including, but not limited to, wet or slippery surfaces, instability of water vessels, enhanced health risks to overexertion, over exposure to the sun or cold, and/or drowning. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THOSE PERSONS RELEASED FROM LIABILITY BELOW, AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION AND THE PARTICIPATION OF ANY MINOR CHILD(REN) NAMED BELOW.

**HOLD HARMLESS, INDEMNIFICATION, AND COVENANT NOT TO SUE.** I and/or the minor child(ren) named below do hereby RELEASE, WAIVE, DISCHARGE, HOLD HARMLESS, AND COVENANT NOT TO SUE PRSF, its Board of Trustees, directors, officers, agents, volunteers, and/or employees (hereinafter referred collectively as "PRSF") from any and ALL RIGHTS AND CLAIMS, losses, demands, judgments, and executions, and any other actions whatsoever, which I and/or the minor child(ren) may have or which may arise out of or be related to any loss, damage, disability, or injury, including death, that may be sustained by me and/or the minor child(ren), or to any property belonging to me or the minor child(ren), which loss, damage, disability, or injury, including death, may arise out of, be related to, or be connected with participation in Activities, WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF PRSF, except that which is the result of gross negligence and/or wanton misconduct, and regardless of whether such right arises in tort, contract, strict liability, or otherwise.

I and/or the minor child(ren) do hereby further AGREE TO INDEMNIFY AND DEFEND PRSF from any loss, liability, damage, and/or other costs, including court costs and attorneys' fees that I or the minor child(ren) may incur due to participation in Activities.

I and/or the minor child(ren) do hereby further agree to OBEY ANY AND ALL DIRECTIONS, RULES, NOTICES, OR REGULATIONS imposed by PRSF with respect to our presence on the property of the Port Royal Sound Foundation and/or while participating in Activities.

**MEDIA AND/OR MARKETING RELEASE.** In consideration for participation in Activities and without any expectation of compensation or other remuneration, now or in the future, I and/or the minor child(ren) do hereby consent to being the subject of photographs and/or video while participating in any Activities, hereby authorize PRSF to use the same for its marketing or related uses, with or without advertising sponsorship, and hereby release PRSF from any and all claim(s) of damages for libel, slander, invasion of privacy or any other claim based on use of said photography and/or video.

This Agreement shall be construed in accordance with the laws of the State of South Carolina and that any mediation, suit, or other proceeding must be filed or entered into only in Beaufort County, South Carolina and/or the federal courts of South Carolina. Any portion of this document deemed unlawful or unenforceable is severable and shall be stricken without any effect on the enforceability of the remaining provisions. This Agreement may be entered as evidence in any such court or similar tribunal as a total and absolute defense to any claim.
