## STANDARDS OF CONDUCT

In order to be safe while having fun during Princess Camp®, we must have standards of conduct for all campers. We will not tolerate violations of these standards. Anyone who chooses to disregard them may be removed from camp. Participation in Princess Camp™ constitutes agreement to these standards.

1. During rehearsals and shows, all campers are to remain in the designated area. You may use the restrooms as needed but must be accompanied by camp personnel. At no time are ~~any~~ campers allowed to leave the area without permission and supervision.
2. It is our responsibility, as a team, to keep the rehearsal space clean.
3. Be ready to begin rehearsal at the scheduled time and be picked up promptly. If you must be late for a rehearsal, inform the Princess Camp™ Director.
4. Personal behavior must exemplify respect to those in authority, to one another, and to the property. Appropriate behavior is described as: “Respectful” & “Responsible”. Respect your director(s) and those in authority, either adults or peers. Respect each other. Show you are responsible by being on time and learning your choreography. Pay attention to the directions given to you & take them seriously. You have a job to do and others are counting on you to do your part!
7. Rehearsals are closed. This means they are for campers only. Please do not invite your friends and family to rehearsals. Exceptions may be granted in advance but only at the discretion of the directors.

With your assistance, we will make this production a memorable event for all of us, as well as for our audience. Your cooperation in adhering to these standards is most gratefully appreciated.

Princess Camp™ staff will provide clear behavior expectations and model positive behavior at all times. Princess Camp participants will be rewarded for demonstrating the respectful and positive behavior required to produce a successful show. Our number one goal is that everyone has a positive and fun experience!!! However, should behavior problems arise with Princess Camp™ participants, the following disciplinary plan will be followed (in general):

1. Verbal warning.
2. A phone call to the parent.
3. Dismissal from the Camp (no refund will be provided to participants who are dismissed from the program)

## PRINCESS RELEASE AND INDEMNITY AGREEMENT

I, \_\_\_\_\_ a Princess in THE 2019 PRINCESS CAMP® do hereby knowingly and voluntarily release *The Miss America's Outstanding Teen, Inc.*, their Officers, Directors, Trustees, Judges and Employees and any other persons, firm, individual or corporation charged or chargeable with responsibility or liability, their heirs, administrators, executors, successors and assigns from and against any and all claims, lawsuits, demands, damages, loss of service, actions and causes of action based upon, arising out of, or in any way related to any honors, rights, or awards sought by me as a PRINCESS in the 2019 PRINCESS CAMP®, the conduct of business there at, the ownership and possession of any honors, rights, or awards thereby, any negligent act, act of misfeasance or nonfeasance by the referenced pageant, or any of their agents, contractors, servants, employees or licensees, in conjunction with any honors or awards bestowed at said listed above from any and all claims that exonerate, hold harmless and indemnify such pageant listed above from any and all claims that I or my representative may have against such honors, rights and awards.

Such indemnification to include any or all fees (including reasonable attorney's fees), costs and other expenses reasonably incurred by or on behalf of the above actions or causes of action. I have had a full and adequate opportunity to be thoroughly advised of the terms and conditions of this release and indemnity agreement by counsel of my own choosing. I have also been afforded the opportunity to ask any and all questions that I have concerning this document and its execution by me.

### **COPYRIGHT, LICENSE, OWNERSHIP RIGHT**

**No cameras of any kind will be allowed backstage at the auditorium.** This includes any devices such as I-Phones, I-Pads, Blackberry's, etc. If any of these types of devices are discovered, they will be removed and given to either a parent or pageant official for safekeeping.

Televising and Sponsorship of National Finals. I understand that Miss America's Outstanding Teen, Inc. makes no representations to me that the National Finals will be televised or broadcast on either a live or tape-delay basis, or that the National Finals will be sponsored by one or more sponsors, or that I will be personally or individually involved in any specific appearance in any broadcast.

Permanent License of Publication Rights. I hereby authorize Miss America's Outstanding Teen, Inc. and anyone duly licensed or authorized by Miss America's Outstanding Teen, Inc. to (1) televise, photograph, broadcast and/or make radio, television, video and audio tapes or motion picture recordings of me individually or in a group; (2) use or re-use such photographs, recordings, video tapes, audio tapes and/or motion picture films in all media throughout the world in perpetuity; and (3) use my name, likeness and/or physical depiction for any purpose in perpetuity, in an unedited or edited manner or fashion as Miss America's Outstanding Teen, Inc., in its sole discretion, shall determine.

## **FREQUENTLY ASKED QUESTIONS ABOUT PRINCESS CAMP™**

- Q: When is Princess Camp™?  
A: Camp runs Monday through Saturday, JULY 22<sup>nd</sup> through JULY 27<sup>th</sup> .
- Q: What ages can apply to Princess Camp™?  
A: Campers must be ages 5-12 by JULY 22, 2019 to register for camp. The registration deadline is June 1st.
- Q: Where does Princes Camp™ take place?  
A: All Camp courses, rehearsals and the final production will take place at the Rosen Centre Hotel and Orange County Convention Center.
- Q: What is included in my registration fee?  
A: Each Princess Camp™ participant receives a badge and a season ticket to the MAOTeen Competition. Campers will be introduced on stage one night during the preliminary competition and perform on stage two nights.
- Q: What should my child wear to rehearsals?  
A: Please have your camper wear comfortable clothes that they can move freely in without restriction. A Wardrobe List along with the Schedule of Events will be sent as we near the event.
- Q: My child is highly allergic to nuts, will campers bring peanut butter to camp?  
A: If your child is highly allergic to anything, please let us know on the medical form and please detail how the allergy affects them. Please underline this very important information. If the allergy is severe, we request that you send your child with an epi-pen or similar treatment. We will do everything we can to maintain a safe environment for those campers as needed, within reason.
- Q: Can my child bring a refrigerated snack to camp?  
A: We suggest limiting snacks as much as possible, as we will have no refrigerator available.
- Q: Can I have a friend pick my child up from camp?

- A: If an adult is not on the camper pick-up and drop off sheet, a parent must tell the director that someone else is picking his/her child up from camp. Also, a signed note must be given to the director written by the guardian allowing pick-up of their child by another adult. Both adults' first and last names must appear on the note and the guardian's signature must match the signature on file.
- Q: Is there anything we, as parents, can do to assist with making the camp successful?
- A: Helping your child see value in the part they have is important. Also, working on choreography every day is very important.
