WE PROMOTED CHARTER SCHOOLS AND PRIVATE CHOICE PROGRAMS, INCLUDING THE SUCCESSFUL RAISING OF THE CONTRIBUTIONS CAP FOR THE TAX CREDIT SCHOLARSHIP PROGRAM TO \$100 MILLION FROM \$58 MILLION.
