The Marin CASA program is appointed to all dependency cases as well as additional probation and probate cases in the Marin County Juvenile Court system. The Marin CASA program recruits, screens, trains and supervises all volunteers who play a critical role in providing a voice for children and youth ages 0-21 throughout the entire court process.

In 2019, over 57 CASA volunteers advocated for over 119 children. CASAs provided over 5,085 hours of voluntary advocacy services.
