### TERMS & CONDITIONS 2020

<u>CHANGES TO RATES</u>	<p>  Victoria Falls River Lodge - Luxury Tented Suites and/or the Victoria Falls River Lodge - Island Treehouse Suites reserve the right to amend rates but will honour any confirmed bookings at the existing agreed upon rates.  </p> <p>  A booking is defined as 'confirmed' when the property has received payment / is holding a valid voucher.  </p>
<u>CHECK IN / CHECK OUT</u>	<p>  It is strongly advised that guests arrive at their Lodge at around 14h00 on their day of arrival and kindly request that rooms are vacated by 10h00 on their day of departure.   Guests arriving after 16h00 will be unable to join the afternoon activity.  </p>
<u>DAY ROOMS</u>	<p>  NIL  </p>
<u>TOURISM LEVY</u>	<p>  The Government Tourism Levy (currently 2% in Zimbabwe) is included in rates quoted.  </p>
<u>VALUE ADDED TAX (VAT)</u>	<p>  Accommodation rates quoted are inclusive of 15 % VAT.  </p>
<u>PAYMENT METHOD</u>	<p>  Accommodation rates are quoted, invoiced and payable in US Dollars (\$).   Direct bank transfer is the preferred method of payment.   Bank charges are for the payee's account.   A 5% surcharge (on the invoice total) will be levied on all payments made via credit card. Cash (US\$), Visa and MasterCard payments are accepted at the Lodge.  </p>

Minimum 2-night stay.</p> <p><b>ISLAND TREEHOUSE SUITES</b> <i>Complimentary concession will be made to the agent / operator as follows:</i></p> <p>For every 9 paying guests – 1 complimentary guest (i.e. the 10th guest will stay free of charge). Minimum 2-night stay.</p>

The percentages are based on the total value of the individual reservation as booked.</p> <p><b>ISLAND TREEHOUSE SUITES</b> <i>Prior to date of arrival:</i> 90 - 60 days = 25%; 59 - 0 days = 100% The percentages are based on the total value of the individual reservation as booked.</p>
<p style="text-align: center;"><u>GROUP PAYMENT POLICY</u></p>	<p><i>Prior to date of arrival:</i> a minimum deposit of 25% is required to secure/confirm a booking. Full pre-payment (or voucher – if credit client) is required 60 days prior to the date of arrival to secure the reservation.</p>

## TRANSFERS

Transfers from and back to the Victoria Falls Airport / Livingstone International Airport (upon arrival and departure) are included in the rate – guests are kindly requested to advise relevant flight times. Guests arriving after 16h00 will be unable to join the afternoon activity.

Private transfers (other than from/to the Victoria Falls Airport / Livingstone International Airport) and / or additional luggage vehicles etc. can be arranged if required for guests staying at either Victoria Falls River Lodge Luxury Tented Suites and/or the Victoria Falls River Lodge Island Treehouse Suites. Kindly contact our team directly for more information regarding the relevant Terms and Conditions and additional costs applicable.

### LUXURY TENTS & LUXURY FAMILY TENTS

It should be noted that, for guests staying at the Luxury Tents and/or Luxury Family Tents, the included road transfers from/to the Victoria Falls Airport are direct (i.e. there are no unscheduled stops between the designated collection and drop off points) and shared (i.e. with other guests travelling to/from Victoria Falls River Lodge).

### ISLAND TREEHOUSE SUITES

For guests staying at the Island Treehouse Suites - road transfers from/to the Victoria Falls Airport / Livingstone International Airport are direct (i.e. there are no unscheduled stops between the designated collection and drop off points) and private (i.e. specific to the number of guests in any particular party).

*All unspecified transfers are at an additional cost. Kindly enquire directly for more information.*

## SHARING CHILDREN'S POLICY

### LUXURY TENTS & LUXURY FAMILY TENTS

0 – 3 year olds: Accommodated at no extra cost. 4 – 11 year olds: accommodated at 25% of the adult sharing rate, with their parents (or 2 x adults) within a Luxury Family Tent. 12 – 17 year olds: accommodated at 50% (half) of the adult sharing rate, with their parents (or 2 x adults) within the Luxury Family Tent. 18 years and older: persons aged 18 years and older are considered adults and will therefore require their own tent at the applicable adult rates.

Children accommodated in their own tent will be charged the full adult rate i.e. the first two occupants of a tent (regardless of age) shall be charged the full adult sharing rate where after the age appropriate discounted sharing child rate(s) shall apply where applicable.

**NOTE:** Owing to the Lodge being unfenced and located in a National Park – and given that the tents are spaced between 40-60m apart – it is not recommended that children younger than 16 years occupy a tent on their own (without an older sibling / adult present).

***NB: Children are the responsibility of their parents/guardians. Pool and / or plunge pools are neither cordoned off nor manned by lifesavers / staff.***

Luxury Family Tents can accommodate up to 3 children - under the age of 18 years (sharing with adults) - in a smaller room adjoining the main bedroom area. This alcove is separated from the main area by a curtain and contains a bunk bed and one single bed. The bathroom is open plan and shared.

Camp cots are available with prior arrangement and each accommodates a maximum of one child. Child minding services are available at an additional cost and are conducted by lodge staff

### ISLAND TREEHOUSE SUITES

No persons younger than 16 years shall be accommodated the Victoria Falls River Lodge Island Treehouse Suites.

Each Island Treehouse Suite accommodates a maximum of 2 sharing guests. Children accommodated in their own Treehouse will be charged the full adult rate (i.e. the first two occupants of a room (regardless of age) shall be charged the full adult sharing rate).

**NOTE:** Owing to the Victoria Falls River Lodge - Island Treehouse Suites being unfenced and located on an Island in a National Park, it is not recommended that children younger than 16 years occupy a room on their own (without an older sibling / adult present).

***NB: Children are the responsibility of their parents/guardians. Plunge pools are neither cordoned off nor manned by lifesavers / staff.***

Subject to availability.</p> <p><b>International: Guide/Pilot</b> - \$308 per person per night (Guide Accommodation) – net and non-commissionable <b>SADC: Guide/Pilot</b> - \$219 per person per night (Guide Accommodation) – net and non-commissionable</p> <p><b>ISLAND TREEHOUSE SUITES</b></p> <p>Owing to the limited number of Island Treehouse Suites available – no reduced rate for Tour Leaders / Private Guides / Interpreters or Pilots is possible. There is also no Guide Accommodation on Kandahar Island.</p> <p>Should guests, staying at Victoria Falls River Lodge Island Treehouse Suites, wish to be accompanied by any of the abovementioned parties – an Island Treehouse Suite will need to be booked for this party and the full rate shall apply. Alternatively – subject to availability – the Tour Leader / Private Guide / Interpreter or Pilot may be accommodated in the tented Guide accommodation at the riverside Victoria Falls River Lodge tented accommodation. Kindly enquire direct for further details.</p>
<p style="text-align: center;">Private / Sole Use Game Viewer</p> <hr style="width: 20%; margin: auto;"/>	<p>Sole use of a vehicle for game drives is subject to the availability of vehicles on the day i.e. if sufficient vehicles are available for a drive, no charge shall be levied. Guests wishing to secure a guaranteed sole use game drive vehicle may book this at the additional, non-commissionable, rate of \$279 per drive.</p> <p>Families staying at the Victoria Falls River Lodge Luxury Tented Suites who wish to take children aged 4 - 7 years on a game drive will require a sole use game viewer – at the additional, non-commissionable, rate of \$279 per drive. Again - if sufficient vehicles are available on a drive, no charge shall be levied, however this cannot be guaranteed ahead of time so pre-booking is recommended so as to avoid disappointment.</p>

For all to get the maximum enjoyment from the visit, consideration for each other is paramount. The Management of Victoria Falls River Lodge Luxury Tented Suites and/or the Victoria Falls River Lodge Island Treehouse Suites therefore reserves the right to warn any guest whose behaviour they deem to be having a negative impact on the safety or enjoyment of any other guest. The offending guest(s) will be escorted off the premises if such a warning be ignored. Any costs (including but not limited to transfers, flight changes, alternative accommodation etc.) arising from such a situation will be for the guests' own account.</p>
<p style="text-align: center;">Force Majeure</p> <hr style="width: 20%; margin: auto;"/> <p style="text-align: center;">(Issued: June 2018)</p>	<p>Victoria Falls River Lodge Luxury Tented Suites and/or the Victoria Falls River Lodge Island Treehouse Suites shall not be compelled to perform any obligation under the Contract if such performance is rendered impossible, substantially more difficult or delayed as a result of Acts, Orders, or Regulations issued by Central or Local Government, industrial disputes (whether official or unofficial), war, riots, hostilities, flood, fire, accident, act of God, epidemic or from any other cause, event or occurrence which Victoria Falls River Lodge Luxury Tented Suites and/or the Victoria Falls River Lodge Island Treehouse Suites is unable to prevent having due regard to its interests.</p> <p>Victoria Falls River Lodge Luxury Tented Suites and/or the Victoria Falls River Lodge Island Treehouse Suites shall not be liable for any loss, cost or delay arising from or because of such non-performance. The onus is on the operator to ensure that their clients are in possession of adequate travel insurance.</p>
