On behalf of the young men attending Timber Ridge School, and our dedicated staff who assist them with their individual treatment needs, please accept my sincere thank you for The Pruitt Foundation anonymous gift of \$20,000.00 (Check #1537 dated 12/17/19) to Timber Ridge School.

Per specific request, the check amount was divided into individual deposits of \$200 to each of our students' savings accounts, 40 students totaling \$8,000.
