

**LIMITED POWER OF ATTORNEY PERTAINING TO HOMEOWNER’S INSURANCE**

- 2. **TO UPDATE INFORMATION**: To update, from time-to-time, any and all information related to the mailing addresses of the Principal(s) and/or Mortgagees, to update the POLICY with to include additional mortgagee clauses, or any additional updates that may be necessary to maintain accuracy of the POLICY; and
- 3. **TO COLLECT MONIES ON PRINCIPAL’S BEHALF IN THE EVENT OF CANCELLATION**: To collect any monies on behalf of the Principal(s) any and all monies refunded to the Principal(s) in the event of POLICY cancellation.

I hereby give and grant unto said Agent full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done to effectuate the powers set forth above as fully to all intents and purposes as I might or could do if personally present.

This Power of Attorney shall survive any disability to myself at any time.
