**Application Deadline is May 1, 2020**

Thank you for your interest in being a vendor at the 59th Annual Peach JAMboree & Rodeo. We are looking forward to another successful Peach JAMboree in the beautiful Texas Hill Country. All applications are due by May 1, 2020. Applications will be reviewed as they are received. Vendors will be promptly notified of their acceptance or non-acceptance via phone or email. **Submission of an application does not guarantee acceptance.** (Check or money order will be returned promptly if not accepted.) The Peach JAMboree is an outside event. No refunds will be given due to inclement weather.

### **Booth Set-Up and Hours of Operation:**

At arrival Vendors will Check-In at the main office located by the ticket windows.

**FRIDAY, JUNE 19** - The chamber grounds (located 1 block off of HWY 290 on Peach Street) will be open starting at 10 AM. Vendors may set up anytime throughout the day, but will need to be completely set up by 5:30 PM. The gates open at 6:00 PM and rodeo events will begin at 8:00 PM, followed by a dance from 10:00 PM-12:00 AM. We ask that vendors keep their booths open until the end of the rodeo. It is the vendor's choice to stay open during the dance.

**SATURDAY, JUNE 20**- Booths should be open at 10:00 AM. There will be a parade & all day events. There will be a short break in the action following the Peach Auction (approximately 4:00) before the rodeo. Feel free to close your booth for a short break, before the rodeo that evening. Please be open again by 5:30 PM. Once again, be prepared to stay open throughout the rodeo. No vehicles will be allowed into the grounds for load out before 1:00 AM. The grounds will remain open Sunday morning. All booths should be removed by 1:00 PM Sunday.

- All commercial food vendors must have a current Texas Health Permit or obtain a temporary permit through the **Gillespie County Health Division, Kelli Olfers, 126 W. Main St., Fredericksburg, TX 78624 (830) 997-7521** ALL FOOD VENDORS MUST BE PERMITTED.

Concessionaire further agrees:

- Concessionaire will furnish their own booth/trailer.
- Concessionaire agrees to conduct themselves and their operations in an orderly manner.
- Concessionaire agrees that this contract is not transferable to any other person or entity.
- **Concessionaire agrees not to sell any soda water, beer or any other alcoholic beverage, ice cream, peach pie or peach cobbler.** These above listed items are reserved for the Chamber of Commerce concessions only.
- Concessionaire is responsible for paying all applicable sales taxes.
- Concessionaire agrees to provide the Chamber with a **Certificate of Comprehensive Liability Insurance and a Health Permit.**
- Concessionaire may purchase ice from the Chamber of Commerce during the event.
- The Chamber of Commerce disclaims any liability for any loss of any kind (bodily, property or financial) caused by circumstances beyond the reasonable control of the Chamber.
- **Concessionaire may not bring alcohol on to the Chamber grounds.**

### General Release and Hold Harmless Agreement

The undersigned concessionaire hereby agrees to indemnify and forever hold harmless the Chamber and any of its officers, directors or agents associated with the Chamber and/or the Peach JAMboree from and against any and all claims, liability and/or expense for loss arising from the use of conditions listed in this agreement and/or surrounding grounds, parking areas or any other facility owned, controlled or used by the Chamber, the concessionaire or their agents, employees or anyone connected in any manner therewith.
