KCBS Style Competition with a double-blind judging.

Judging will be on appearance, taste, & tenderness.

You will buy your own meat at a USDA Certified place of business. Meat can be prepped and injected but not seasoned until host has inspected all meat and original packaging to verify it has been USDA inspected. All meat must be kept at a temperature below 38 degrees. Absolutely NO Wagyu or Kobe Beef allowed.

Exhibitor's may begin set up Friday Night July 30th, 2021 after 9:30PM. This time is to allow our Friday Night Entertainment to clear the parking lot. Host will be around to each individual exhibitor to inspect packages before 11PM.

Cooks Meeting at 11:30AM Saturday July 31st, 2021. You will get your turn in boxes at that time.

We ask that you plan for the public sampling. This meat does not have to be what is turned in just that it be prepared with the same spices and seasoning.
