This is a renewal of a S+C project was transferred to a free standing agency through HUD approval and grant agreement. The grant provides rental assistance for 3 chronically homeless individuals with a mental health disability. In this rural community there are very limited services for the homeless, this is the only HUD funded program in the county for homeless, there is no emergency shelter in the county and very limited safe, decent affordable housing sites. Housing for the disabled with limited income is small and waiting lists are common. Section 8 has provided a few openings and we have been successful at transitioning to this resource for permanent housing. Family Life got a late start due to having to wait on the grant agreement and then the transfer with HUD approval to them.
