This is a 19 permanent supportive housing bed project designed to serve chronically homeless individuals/families. This project was a reallocation from the previous year. Housing 1st is the practice that will be utilized for this PSH. Participants will be moved into PSH quickly and while in housing, supportive services will be wrapped around the participants. They will not be screened out based on income, history of substance abuse, criminal record except for state-mandated restrictions, or history of DV. A coordinated assessment is used to assist in the identification of targeted population, their needs/issues as well as other assessments necessary to effectively address the needs of the targeted population. All participants will be entered into the HMIS program as well as performance measures including housing stability, increase income/skills, and greater self-determination and access to mainstream resources.

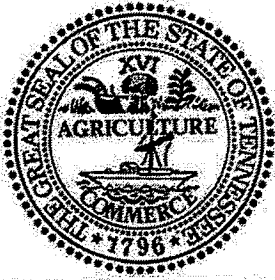

This letter is in response to your request for affirmation of your organization's exempt status.

Our records indicate that a determination letter issued in September 1979 granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.




