### AAUW Fort Wayne Branch Salutes Marsha Miller

It has been a privilege and honor to have Marsha Miller serve as our Indiana State AAUW President. She has brought distinction and a creative flair to our organization that deserves to be recognized by our organization. Marsha will be stepping down from her AAUW position this summer.

Besides devoting many years to help AAUW achieve our goal of 'Advancing EQUITY for Women and Girls', Marsha has had a lengthy career coordinating the library social media for Indiana State University in Terre Haute, Indiana. In her work, she has taught more than 4,800 information literacy sessions, is an astute historian and continues serving her community to advocate for the rights of women and preserve our right to vote.

### Come & Celebrate!

Members will recall that in celebration of the 100<sup>th</sup> anniversary of 19<sup>th</sup> Amendment being ratified, unfortunately our December AAUW Brunch featuring our guest speaker, President Marsha Miller, had to be cancelled. Fortunately, we were able to reschedule her presentation for our May 8, 2021 AAUW Brunch which we hope you will attend.

Her presentation titled, "From Amanda to Zerelda: Hoosier Suffragettes Who Raised a Ruckus" will explore the 69-year chronological history of women's suffrage in Indiana. Marsha will introduce Hoosier women who helped shape the movement, including Amanda Way (who is considered 'the mother of Indiana suffrage'), Helen Gougar (a feisty publisher and lawyer based in Lafayette), Zerelda Wallace (one of the founders of *Indiana's Equal Suffrage Society*), and women who moved into the national suffragist sphere, including May Wright Sewall (educator, and civic organizer), and Ida Husted Harper (a journalist and close friend and biographer of Susan B. Anthony.)

When the 19<sup>th</sup> Amendment was finally ratified, women throughout the country celebrated their achievement. The battle that our 'Foremothers' took on in Indiana was a long and hard-fought victory. We would like to think that the right to vote was gained for **ALL women**. However, as the journey to improve voting rights continues, we have come to realize that there are still many people in society whose votes are being suppressed. (continued page 2)

### ***'Equal' Suffrage Movements in Indiana***

For years, people of color, Native Americans, and others have continued to be denied their right to vote. By 1912, 'Equal' suffrage groups were formed by the commendable efforts of women like Carrie Barnes Ross, who was the first president of Branch No. 7 of the *'Equal Suffrage Association'* of Indianapolis. This Branch became the first African American organization in Indianapolis with its mission to promote **'equal' voting for ALL**. Please continue reading about this historical movement in the article written by our Branch member, Linda Manning. ### ***Suffragettes & the New Tech in Town!***

By 1912, the automobile and telephones were the 'new tech' in town. Our savvy Suffragette Foremothers were smart in utilizing these new tools to help *'drive home their mission'* (pun intended!) Through utilizing the new tech tools, networking with other women, and raising a 'ruckus', Hoosier women finally got the Indiana Legislature to ratify the 19<sup>th</sup> Amendment! (Morgan, A., 2020)

However, there is still much work that is needed in our state. The votes of many Hoosiers are still being suppressed. The battle to get a fairer 'redistricting' of voters throughout the state is still being fought. AAUW still has a great deal more work to improve the lives of **ALL women!**

## Nineteenth Amendment Equal Voting Rights – A Call to Action!!!

As we know, the nineteenth amendment states that "the right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of sex." Even as it was ratified, many African-American women were unable to vote due to state laws. It took nearly five more decades for that to happen. "After the passage of the amendment, women were not broadly mobilized, and in many places, women of color continued to face barriers to voting. This meant that the first women to vote were largely white, wealthy or living in states that made it easier for women to vote." Poll taxes and literacy tests prevented Black citizens from voting until the 1965 Voting Rights Act outlawed discriminatory voting practices. Black suffrage clubs began forming in Indiana in 1917. Carrie Barnes Ross, an African-American woman, was the first president of one of these clubs in Indianapolis. " Black suffrage clubs also organized suffrage schools as crash courses to teach Black women about the state constitution, elected offices, how to register to vote and what the polls would look like." Black ministers were asked to try to get women to join the movement and form suffrage groups. Frances Berry Coston also worked with Ross for the suffrage movement as well as teaching courses in voting within segregated elementary schools. Sadly, many of the works of the Black community are unrecorded due to lack of coverage in many newspapers, especially those owned by white men.

It is reported that many white suffragists discriminated against Black women. "Before a parade in 1913, famed Black journalist and activist Ida B. Wells was asked to march at the back of the parade instead of alongside white suffragists. But Wells refused to join her fellow Black suffragists in the back. Instead, as the all-white Chicago delegation passed, she walked out of the crowd and took her place alongside them." Black women have become essential to the victories of the Democratic party. According to Taylor Crumpton, writing for the Washington Post, "Black women are the country's most powerful political force. " Many Americans today still do not have full voting rights. Voter intimidation and suppression efforts still remain 100 years later. The **100th anniversary** of the nineteenth amendment should not be just a celebration, but **a call to action for full equality to be attained.**

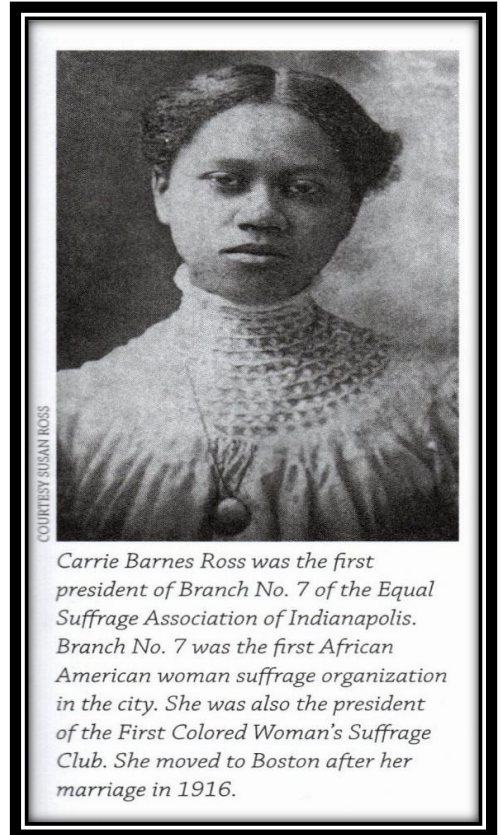

**Want to Get Involved with helping women in Fort Wayne???** A strong supporter of helping women to improve their lives, AAUW member, Cathy Huff Helt, has learned of a new project that needs help!

**St. Joseph Missions** is sponsoring a newer project to help single homeless women to obtain shelter and get their lives back. Unfortunately, the stories of the women who need help are all too familiar in our city. Many of them wander the streets and neighborhoods with nowhere to go. This leaves them in very dangerous situations and vulnerable to becoming victims of violence, abusive relationships, and of sex trafficking.

How big a problem is it? According to the most recently published report, 1,022 single women identified themselves as homeless when calling in to United Way of Allen County’s 211 Center over the course of a year. The majority were ages 19-39, but the 60+ age group has grown dramatically. Surprisingly, some of these women were employed part-time or even full-time yet found themselves homeless for the first time.

Area homeless advocates confirmed that the population most in need of service among the homeless is single women. In Allen County, there are few, if any, beds allotted to single homeless women on an emergency basis. The **St. Joseph Missions Women’s Shelter** will become **Fort Wayne’s first 24/7/365 days a year emergency shelter for single homeless women**. However, the project is designed to be more than just a refuge for the night. The women’s shelter will provide a safe, supportive, and structured environment that honors women’s dignity and empowers them to become self-sufficient.

On Friday, March 5th, the Trust Board of Directors met for our important task of voting on the grant applications. There were FIVE applications selected for grants for 2021. They are listed below, totaling \$11,800.00.

Our AAUW Trust Public Meeting will be held on **Wednesday, April 14<sup>th</sup> at 6:00pm** at the downtown library - Room C. Grant recipients from 2020 will report about their projects and how the grant money was used. This year's 2021 new recipients will receive their checks and will be available if anyone has questions.

It is an exciting time, each year, to know that our local Trust that is **40 Years old** this year has helped so many local nonprofits!

We still encourage any donations to our Capital Account whenever you are able.

1. **AAUW Fort Wayne Branch** – \$3,000.00 for our communications - newsletters, yearbook, and website expenses.
2. **Ruth Tyndall Baker** (Member Grant) – \$2,100.00 for play production supplies for “Unleashed Women: The Hamiltons”.
