Transitional & Supportive Housing

Our Transitional Apartment Complex provides safe, temporary and affordable housing for families with children that are homeless. This program helps the family identify the circumstances that contributed to their obstacles.

Solutions to End Homelessness

STEHP provides assistance to families who are homeless or at high risk of becoming homeless. Intensive case managers provide home-visiting services. The support provided adjusts to families' needs, ranging from temporary rental and utility assistance for at risk families to temporary or permanent housing for homeless families.

Emergency Rental Assistance

ERAP assists tenants and landlords impacted by COVID-19. OTDA will provide back rent due to financial difficulties experienced during the pandemic.

Get Help if You're Struggling

The COVID-19 Pandemic has left many Madison County residents dealing with reduced income or unemployment. If you've been affected financially by the pandemic and you own your home, Community Action Partnership may be able to help you with mortgage assistance.

COVID-19 Mortgage Relief Program

This program will provide assistance to help Madison County residents pay past-due mortgage payments if they are behind due to loss of income related to COVID-19.

The mortgage subsidy will be paid directly to the mortgage holder. Madison County residents who have owner-occupied rental properties are only eligible for mortgage assistance for the portion of their mortgage related to their primary residence, not the rental portion of their property.

What Do We Need?

Required Documentation:

- Proof of COVID-19 Related Loss of Income*
- Current Photo ID (e.g. -Driver's License)
- Income Eligibility Documents*
- Copy of Social Security Card
- Notice of Past-Due Mortgage
- W9 Form Completed by Mortgage Lender

*Self-Attestation is permissible

Who Qualifies?

You must fall within the income guidelines listed below:
