To Whom It May Concern:

Please find below the outline for our various on-site training programs. I have also included the CFI training process outline for your review. The CFI outline will help you understand what each participant would need to do in order to receive a certificate of completion and be recognized in our registry as a trained CFI interventionist. In addition, we offer many FAQ's that should answer questions about the training, and the next steps for persons interested in the CIP credential.

Closed On-Site CFI-Training - \$10,000 Flat rate + travel

Baystate Recovery Services offers select treatment programs with a **closed (on-site) CFI-Training** option. This training is a live (on-site) presentation, providing **24 PCB, NAADAC, and NASW approved CE's** that can be used toward initial certification or re-certification for CIP through the PA Certification Board. This option is provided as a three-day training conference at the venue of your choosing, or it can be broken down into one day per week trainings that can take place over the course of three consecutive weeks (*certain location conditions apply*).

We must have at least 30-day's notice prior to any training to submit for CE approval. This time also offers our clients and their program the chance to enroll as many staff/students as allowed to lower the per-person cost for the program.

Open On-Site CFI-Training - \$4,000 Flat rate + travel

Baystate Recovery Services offers select treatment programs the opportunity to host an **open CFI-Training** option. This training is a live (on-site) presentation, providing **24 PCB, NAADAC, and NASW approved CE's** that can be used toward initial certification or re-certification for CIP through the PA Certification Board. This option is provided as a three-day training conference at the venue of your choosing. This training also comes with **4 training seats** for any staff or special guests of the program, that would like to attend.

Hosting program will have the chance to give tours and discuss their treatment program, in depth, to students.

We must have at least 30-day's notice prior to any training to submit for CE approval.

Hosting program must be able to guarantee 6 training seats, in addition to the 4 seats reserved for the program, at \$1,000 per seat.



Hosting Program responsibilities:

The hosting program will provide the following

- A venue for each day of the training (3-days / 24 hours + breaks)
- Advertising /publicity if the event is open to the public
- 12 student guarantee – open or closed training
- Morning and afternoon meals and refreshments for student and facilitators
- Names and emails for registered participants within one week prior to the training
- Appropriate space for presentations (projector screen / Whiteboard / room for role-play)

CFI facilitators responsibilities:

The CFI training program will provide the following

- All training material (workbooks, handouts, certificates, PowerPoint, etc)
- 24 hours (3-days) interactive / comprehensive training for staff/students
- Certificates of completion (**PCB - NAADAC - NASW CE Credit**)
- 90-days of extended education and group supervision

Our on-site training program is set with a limit of 16 participants to ensure that each individual participant gets the appropriate amount of student - facilitator attention. Each individual will have the chance to showcase and explore their comprehension of the training material through our intensive mock intervention setting on day three.

This program-specific training will ensure that each participant gets the most out of what is being offered, and can find the most effective way to integrate the learned material into their own position within the program.

Travel expenses will be applied in certain situations if the training requires our facilitator(s) to secure lodging or travel outside of the local 50-mile radius - MA, NH, RI, ME area.

Becoming a (CFI) Trained Family-Focused Interventionist

CFI 3-Day Intervention Training Workshop *(no prerequisites for participation)*

Step Two: Complete 90-day CFI-Extended education & support process

CFI 90-day (EES - Supervision) program *(prerequisites for participation)*

- Successfully complete initial 3-Day CFI training process (within 2 years)
- Seeking additional support for their practice as a CFI trained interventionist

Participants in our 3-day intensive training are not required to utilize the supervision portion of our training process; however, those participants will not be able to declare or advertise themselves as a CFI trained interventionist until the supervision portion has been completed to the satisfaction of BRS staff, and the individual is in pursuit of, or already has, their CIP credential. These participants will be labeled as **ETC** (Educational Training Completed) only, on our professional registry page.

Individual supervision hours

Individual supervision hours can be available for students with a CIP during the 90-days after completing our CFI-Training. These individual supervision hours can include case review, intervention prep with families, and the practical application of these tools to perform interventions. *For additional individual supervision hours beyond the 90-days included in this process, please call for pricing.*

Step Three: Certified Approved - CFI-Trained Interventionist

Practicing CFI-Trained Interventionists

Requirements:

- Complete **3-Day Intensive Training Program**
- Hold and maintain professional liability/malpractice insurance
- Hold and maintain clinical licensure - Hold or pursue CIP certification - Membership to an industry specific professional organization with a governing body of ethics
- Complete **CFI-Extended education & support** to the satisfaction of the BRS staff



FAQ's

CFI Training Program

*What does the CFI stand for?

The CFI acronym denotes a "Family-Focused" approach which allows the trained individual to utilize all aspects of the family system to achieve the desired results. This would be applicable in a variety of stages within the continuum of care including individual client support.

*What does, becoming CFI trained, mean for me or my staff?

As an approved education provider for both the PCB (Pennsylvania Certification Board) and the NASW (National Association of Social Workers) we offer our students a thorough and intensive education on our model of intervention.

Our CFI training is in our model of intervention only, and is one of the many training options that an Interventionist, or interested individual, may have on their journey toward attaining their CIP credential.

We highly recommend additional trainings, supervision, and eventually the pursuit of the CIP credential through the PCB (Pennsylvania Certification Board) prior to performing independent intervention services.

*Will I, or my staff, be able to perform interventions upon completion of this training?

Although some students may have previous education and experience, others may not. Our training should serve as a part of a larger educational experience for intervention work, and should not be considered as a stand-alone training providing intervention credentials.

We highly recommend additional trainings, supervision, and eventually the pursuit of the CIP credential through the PCB (Pennsylvania Certification Board) prior to performing independent intervention services.

FAQ's continued...

***If our goal is to provide interventions, what steps should be taken?**

Becoming an interventionist should be like any other education. This is a complex and difficult field to work in, and will require an in-depth education in multiple modalities of intervention, along with a strong supervision and support system.

We would recommend that you review the **CIP guidelines**, as they provide a detailed outline of the path ahead for interested professionals.

For those individuals seeking their CIP certification (Certified Intervention Professional) please visit the PCB (Pennsylvania Certification Board) website www.pacertboard.org to learn about the additional requirements you must fulfill in order to complete your CIP certification.

***Who provides the supervision, and is there a sign-off that then drives certification completion?**

The supervision element of our training is customized for the participants. We have some clinicians or previously certified individuals who may need less attention, and we may have some others that require a heavier hand, so to speak.

We currently provide all supervision as group video meetings scheduled for a minimum of once a month for 90-days post-training. Given that a trainee has successfully completed the initial 24 hours and has participated in our video supervision groups they would be signed off on for program completion.

Additional supervision is available in a more case specific and interactive manner as a part of a separate package, but this level of supervision is not required to receive the CFI certificate of completion.

***Will our staff need to seek out additional insurance or membership to be certified?**

The insurance and membership expectations only apply if said individual intends to branch out and perform interventions on their own. It is to ensure that we are not promoting unregulated individuals seeking to build their own brand as interventionists from running around uninsured or without some oversight. Your program participants would most likely fall under your supervision and insurance, and would therefore be exempt from that requirement.
