College Area Livability Task Force

- 17 properties received notifications, which was down from 50 properties receiving notices in Fall 2018. Of the 17 properties, four homes were owner occupied and the remaining homes were rentals.
- Two properties received more than one notice on a different day.
- The majority of the notices were for trash totes. The other issues was litter on the property or non-complaint furniture.
- Two properties received notices for multiple issues (trash totes and litter on property).
- b. Downtown Taverns (Sage Gerling)
 - Ms. Gerling reached out to the owners of Beef & Brew to meet with Mr. Flowers and Chief Passalacqua regarding issues related to popularity of the establishment with students. We are waiting to hear back with their insights on how we can be of assistance.
- c. Police Department Updates (Chief Passalacqua)
 - Overall, a good year for student activity off-campus. Arrests were down. The police department received one noise complaint. The police department has been walking the detail and proactive in talking to students at the beginning of parties before the noise escalates to a complaint.
- d. HWS Updates (Robb Flowers)
 - Mr. Flowers concurred that this year has been overall a good group of students. HWS Campus Safety was out every weekend night as well.
