- Tournament schedules will not be mailed to participants; participants will have to check the tournament website for updates of schedules.

1. ELIGIBILITY OF PARTICIPANTS

- 1.1. This tournament is opened to all Singapore Citizens, Permanent Residents, and individuals residing and/or studying in Singapore with valid passes, for Age Categories.
- 1.2. The top 10 players of each age group, as ranked by the Singapore Badminton Association (SBA) as off 12 May 2021 will not be eligible to take part in this tournament. Ranking can be found on <https://sba.tournamentsoftware.com/ranking/ranking.aspx?rid=266>. Participants to check on the ranking before registration. There will be **NO** refund of the entry fees.
- 1.3. Age qualification shall be based on the following (SINGLES): **(CALENDAR YEAR)**

Age Group	Birth Year	Age in 2021
11	Born in 2010	11
12	Born in 2009	12
13	Born in 2008	13

- 1.4. Age qualification shall be based on the following (DOUBLES): **(CALENDAR YEAR)**

Age Group	Birth Year	Age in 2021
Under – 13	Born in 2009 or later	12 years old or younger
13	Born in 2008	13

- 1.5. A player can participate in his/her age group category or a higher age group category but NOT in a lower age group category. (E.g. A player 11 years of age in 2021 is eligible to participate in the Age Group 11 Singles and U12 Doubles events).
- 1.6. Organizers may request evidence of eligibility during the tournament. Any player found ineligible will **NOT** be allowed to play and the player will have to concede walkover for that match. There will be **NO** refund of entry fee.

2. ENTRY & REGISTRATION

- 2.1. Each player is ONLY allowed to enter a maximum of 2 events.
- 2.2. The registration fees for each event are as follows:
 - 2.2.1. Singles – S\$60.00 per entry
 - 2.2.2. Doubles– S\$120.00 per pair
- 2.3. Payment for the registration fee is accepted **online** and is non-refundable.
- 2.4. Closing date for registration is on **30 May 2021**.

- 2.5. A maximum of 32 entries per event will be accepted on a first-come-first-served basis.
- 2.6. List of participants will be released on **31 May 2021**.
- 2.7. The Organizer will conduct draws on **31 May 2021**.
- 2.8. The above information stated in 2.6 and 2.7 will be released on the tournament website and announced on our official Facebook Page: <https://www.facebook.com/victorsport.sg>.
- 2.9. There will be no seedings for this event.
- 2.10. In the event of insufficient entries for any event (i.e. less than 16 entries), the event/s may be merged with the same event of another age category or be cancelled.
- 2.11. If there are less than 16 entries in any event, the prize money/ prizes for that event may be reduced.
- 2.12. The prizes will be determined by World-Champ Marketing, the organiser for this tournament.

3. TOURNAMENT FORMAT

- 3.1. The tournament will be conducted in a **Round Robin (8 groups of 4)** format at the Preliminary stage, followed by **Knock out** for Top 16 (**Top 2 of Each Group**), Quarters, Semis and Finals for all events.

4. TOURNAMENT RULES

- 4.1. The tournament will be conducted in accordance with, but not limited to, the Badminton World Federation (BWF) Statutes and General Competition Regulations (GRC). In the event of any dispute, the decision of the Tournament Referee will be final.
- 4.2. The scoring system will be based on the best of 3 sets of 21 points for all categories.
- 4.3. All matches will be played in accordance with the schedule of play. Postponement of any matches will be at the Organizing Committee's discretion.
- 4.4. All players are required to bring along their **photo identification documents** for verification on days of their matches upon registration.
- 4.5. Once entries have been accepted, no replacement/substitution of players will be entertained. However, the Organizing Committee, at its discretion, reserves the right to accept such changes if necessary and with valid reasons, so long as no match has been played by the player/s.
- 4.6. All players must report to the Official Registration Table at least 30 minutes before the scheduled time of their matches.
- 4.7. Players will be given a grace period of a **maximum 5 minutes** for all matches, failing which the player will concede a walkover for that particular match.
- 4.8. In the event that both players fail to turn up, the match will be scratched.
- 4.9. Players who concede a walkover in one event, will still be allowed participation in other events, unless otherwise decided by the tournament referee.
- 4.10. Players shall wear non-marking shoes during the competition.
- 4.11. The competition format will be based on the best of **3 games of 21 points** for all categories.
- 4.12. Players are given a minimum of 30 minutes rest period before commencement of the next match at any round (including semis & finals).

- 4.13. The decision of the umpires and officials shall be deemed as final.
- 4.14. Players are required to stay on the court AFTER their match had ended, to act as line judges for the following match. Players who fail to do so will lead to a disqualification and/or ban from future tournaments. Players may also be called randomly to act as line judges for the 1st round of matched for the session.
- 4.15. There will be line judges provided for the finals of each event.
- 4.16. From quarter-finals onwards, all doubles pairs are required to wear attire of at least the same color, if not the same design and color.
- 4.17. The Organizing Committee has the right to amend the rules & regulations prior to the commencement of the event.
- 4.18. The appointed shuttlecock for this tournament is VICTOR Champion No. 1.

5. PRIZE & INCENTIVES

- 5.1. Total incentives in the form of **“Equipment”** to be awarded to prize winners. A breakdown of each event is as follows (**Tentative**):

- 5.2. Prize winners are required to attend the prize presentation ceremony in proper sporting attire. NO singlet or slippers are allowed.
- 5.3. All prizes may not be exchanged for cash or other products.

- 6.2. You are gently reminded to check your eligibility carefully before registration.
