 - B. Reviewed a RFL applicant. Borrower is Jade Berglan and Josh Fagan (dba JJ's Quickshop, LLC). The project is to reopen a convenience store in Billings, OK, that shut down in 2018. There is no fuel available in Billings for residents and visitors, and no agriculture fuel within 15 miles for the local farmers to use for their farm equipment. The store will have groceries (refrigerated and shelf-stable), a deli, grill and pizza oven. Currently there is no place in Billings to buy meals. They intend to hire 10 employees (some full time, some part time). Loan amount is \$125,000. Term is 180 months at 4% interest rate. After much discussion among the board members, Mandevill made the motion to approve the application with a second from Dungan. Voted Yes Bolz, Clonts, Darr, Dungan, Hague, Henderson, Hess, Hyde, Johnson, Mandevill, May, Morris, Moss, Powell, Schrahl, Tucker, Trissell and Walker. Abstain Lantz. No None. Motion carried.
