The instrument may be returned at any time during the Purchase Period and with no further obligation if all payments are current.**

1. To secure your payment and performance under the terms of this contract, you give us a security interest in the goods purchased.
2. Customer will be responsible for any loss and/or damage to the described property.
3. In the event of default of any of the terms of this agreement, Crossroads Music may take possession of the instrument wherever found, at the school or elsewhere, with or without the customer's knowledge.
4. Customer will be liable for any collection and repossession costs.
