works made for hire by LOMAN CREATIVE SERVICES for CLIENT. Except as set forth below, CLIENT shall exclusively own all United States and international copyrights and all other intellectual property rights in the Deliverables.

CLIENT may, at its sole option, terminate any or all work outstanding, or any portion thereof, immediately upon written notice. Upon receipt of notice of such termination, LOMAN CREATIVE SERVICES shall inform CLIENT of the extent to which performance has been completed through such date, and collect and deliver to CLIENT whatever work product and Deliverables then exist in a manner prescribed by CLIENT. LOMAN CREATIVE SERVICES shall be paid for all work performed through the date of receipt of notice of termination as specified herein. This does not apply to any website design payment plans, specials and payment arrangements. ALL SALES ARE FINAL with website design payment plans, specials, payment installments and arrangements and there no refund. All payment installments must be received before website development.
