## Conformation Class Rules

### Trainees:

Trainees are permitted to train only one dog during a training class unless approved by instructor. Each person is responsible for the conduct of the dog they are training. Only one trainee per dog is permitted on the class floor. Please wear comfortable, flat shoes for your safety.

### Junior Handlers:

Trainees must be a least 9 years of age. Trainees under the age of 16 must be accompanied by a parent or other responsible adult. Parents must sign the training application for any trainee under the age of 18. The training committee reserves the right to ask an adult to take over if they feel that the experience is detrimental to the trainer or the dog, or is disruptive to the class.

### Dog Behavior:

The instructor shall have the right to dismiss any dog that is aggressive and is not able to be adequately and safely handled by the trainee. Any dog that is repeatedly disruptive to the class will be dismissed.

### Class Cancellations:

Classes will be canceled due to inclement weather if Fox Valley Technical College cancels its classes or at the discretion of the Conformation chairperson . Classes cancelled due to weather will be rescheduled for the week after the end of the session.

### Use of the Facility:

While you are attending WDC classes, you may use the fenced in yards for 30 minutes before and after class. The yard in front is for puppies and small dogs. The yard in back is for dogs of any size. If other dogs are in the yard, be sure to ask before you bring your dog into the yard. Some dogs are not friendly to dogs they do not know. There is a 15 minute limit on yard use if people are waiting. No unattended dogs are allowed in the yard. Prong, slip, or martingale collars are not allowed when dogs are playing with other dogs for safety reasons. Long leads are not permitted on dogs in the yard if other dogs are present. Please do not potty your dog on the grass strip on the far side of the parking lot. **Most important, be sure to clean up after your dog. Scoops and garbage cans are located throughout the yard.**
