



**2020 Benton County Fair Jr. Queen and Miss Pageant**  
**August 1, 2020 at 7:00 P.M.**  
**Entry form and fee due: Online by July 22, 2020**  
**14-23 Years \$50 total**  
**(\$48 entry + \$2.00 processing fee)**

## Rules

- 1) **Age Qualifications**
  - a) JR. Queen: Contestant must be at least 14 years of age and no more than 17 years of age on the opening day of the Benton County Fair (August 1, 2020).
  - b) Miss: Contestant must be at least 18 years of age and no more than 23 years of age on the opening day of the Benton County Fair (August 1, 2020).
- 2) **Contestant must be a legal resident of Benton County. This means you must LIVE in Benton County. Per State Fair rules, going to school in the county does not constitute residency.**
- 3) **A contestant, cannot be, or at any time have been:** married, engaged, annulled marriage, pregnant, miscarried, aborted or have had a child. A contestant must not have ever been convicted of any crime or have any criminal charges pending. Failure to comply will result in disqualification or revokement of title.
- 4) **Miss Benton County and Miss Benton County Jr. Queen winners will be required to compete at the State Fair Pageant in October.**
- 5) **Contestants are required to be on time for all rehearsals and events.** Absent or tardy contestants may be disqualified at the discretion of the Pageant Director and/or Fair Management. **If you are unable to attend or be on time, due to an emergency, contact the Pageant Director per email.**
- 6) Contestants, competing in the Benton County Fair Miss and Jr. Queen contest must conduct herself properly at all times. Inappropriate behavior bringing unfavorable publicity to herself and/or the Benton County Fair may result in the Queen relinquishing her title and the forfeiture and return of all prizes and monetary awards.

## How to Enter

- 1) Entry forms are available at [www.bentoncountyfairar.org](http://www.bentoncountyfairar.org)
- 2) **NEW THIS YEAR,** you must register and pay online **by JULY 22nd, NO EXCEPTIONS.** It will be \$50 total (\$48 entry and a \$2.00 processing fee).
- 3) TO ENTER ONLINE:
  - a) Go to <https://bentonar.fairwire.com>
  - b) **If you are entering more than one person online**
    - i) Select "Quick Group" this way you only have to pay the processing fee one time!
    - ii) Then select, register and fill in the information. Once to Departments- Choose beauty pageant and select your division.
  - c) **If you are only entering one person online**

- i) Then Select, register and fill in the information. Once to Departments- Choose beauty pageant and select your division.
- 4) After you have paid online, please fill out the google form located at <https://forms.gle/nwjR8jsuZJatuVN36>. (This will also be in “Tips” at the top of the ShoWorks site).
- 5) **DO NOT MAIL YOUR FORM TO THE FAIRGROUNDS.**
- 6) Confirmation emails from the Pageant Director will be sent out on July 24, 2020.
- 7) DO NOT email the pageant or fair to check on the status of your application.

## Pageant Day

### Rehearsal

- 1) Check in will be from 2:00-3:00pm. You MUST be registered and checked in at this time in order to compete, **NO EXCEPTIONS.**
- 2) All contestants will receive their numbers when they check in.
- 3) Rehearsal will begin strictly at 3:00 pm. You MUST attend orientation and rehearsal to compete, **NO EXCEPTIONS.**
- 4) Attire
  - a) Rehearsal is closed to the public, contestants are free to wear comfortable clothing, hair in curlers and no makeup if desired. We recommend the contestants rehearse in the same shoes they will wear in each phase of competition.
- 5) **Contestants MUST follow the walking pattern they are taught, failure to comply will result in deduction of points.**
- 6) After the conclusion of Rehearsal; contestants will be free to begin preparing for competition.
  - a) There WILL be a dressing room for contestants to change in. **NO MALES ALLOWED. NO HAIR/MAKEUP ARTIST ALLOWED. ONLY ONE PERSON PER CONTESTANT. NO PHOTOGRAPHS IN THE ROOM. NO FOOD/DRINKS. Failure to comply with these rules will result in disqualification.**

### Interview and Sportswear/Swimwear

- 7) Directly following rehearsal, afternoon competitions will begin.
- 8) Private Interviews will begin at **4:00 pm**
  - a) **This competition is for both Miss and Jr. Queen Contestants**
  - b) Attire;
    - i) Dress or Suit, Jewelry and shoes of choice – no hats, gloves or purses.
  - c) **This will account for 50 percent of a contestant’s total score.** All interviews will be seven minutes long and will be timed and monitored.
  - d) Judges are instructed to avoid current affairs and religious or political questions.
  - e) The Judges and Contestants are NOT allowed to shake hands or have any physical contact. **Failure to comply will result in deduction of points.**
- 9) Sportswear/Swimwear competition will be directly following interview:
  - a) Private Sportswear is **for Jr. Queen only**
    - i) Sports attire representing favorite athletic-type sport such as baseball, tennis, cheerleading, hunting, fishing, gymnastics, dance, etc.
    - ii) Props are acceptable, but must be carried. **They cannot be used to demonstrate the sport being modeled. Failure to comply will result in deduction of points.**
  - b) Private Swimwear is **for Miss only**
    - i) One piece swimsuit, shoes and accessories of choice. Swimsuit must be MODEST. High heels are recommended, but not required. No tankinis or monokinis allowed.
    - ii) Sarongs may be worn but MAY NOT be removed during contestants modeling pattern.
  - c) **Sportswear/Swimwear will account for 15% of the contestants overall score.**

- i) Over-all first impression, physical fitness, energy level, posture, poise, personality, stage presence, and confidence are taken into account. All males will be asked to step out of the auditorium and all females not competing must go to the back.
- 10) Following the interview and sportswear/swimwear competitions, contestants will be free to leave and come back for later competitions.

### **EVENING COMPETITIONS**

- 11) All contestants will need to be back at the fairgrounds and checked in by **6:30 P.M** for fair wear and evening gown and onstage question. You will sit in the audience until your age group is called backstage for lineup. We will start with the PreTeens and end with the Ms. contestants. **There will be a dressing room available to change in at this time.**
- 12) Evening Gown/Onstage Question
  - a) Evening gown attire is as follows; Evening Gown of choice. Jewelry and accessories should be tasteful and compliment the gown. High-heeled shoes are recommended, but not required.
  - b) The Evening Gown Competition will account for 35 percent of a contestant's total score.
  - c) Judging will be based on overall first impression, beauty, stage presence, personality, grace, charm, walk, appropriateness of evening gown and composite appearance. Each contestant will be asked an on-stage question and will be allowed a maximum of 30 seconds for their extemporaneous response, her ability to answer confidently, as well as her tone of voice, will be included in her Evening Gown score. Judges are instructed "not to judge the gown", but to "judge the contestant in the gown."

## **Logistics**

- 1) **Awards Provided:**
  - a) **Miss Benton County will receive;** \$750 Scholarship to the institution of her choice, rhinestone crown, sash, certificate, and a prize package.
  - b) **Miss Benton County Jr. Queen will receive;** Rhinestone crown, sash, certificate, and a prize package.
  - c) **Runner ups** will receive a plaque. Number of runners up will depend on the number of contestants per division.
  - d) **Overall Interview and Overall Sportswear/Swimwear** will receive a plaque. This will be given to the contestant who received the highest score in each competition.
  - e) **Audience Favorite** will receive a plaque. This will be given to the contestant who receives the most votes in each age group.
- 2) **Judging:**
  - a) The judges may deduct points for excessive make-up, incorrect attire, or age-inappropriate clothing. Judges will not count off for casts, missing teeth, bruises, braces or anything else that a child normally encounters during childhood.
  - b) The pageant will pick qualified and impartial judges and their names will not be released before the pageant begins.
  - c) Score Sheets will **NOT** be given out or made available at any time. This is in accordance with the Arkansas State Fair Pageant. All decisions of the judges are final.
- 3) Miss Benton County and Miss Benton County Jr. Queen will be required to compete at the State Fair Pageant in October.
- 4) Winner must attend all events and complete all duties outlined in Miss Benton County Fair Queen and Jr. Fair Queen contracts. Failure to do so will result in forfeiture of title and all winnings. First runner up will take over at this time.
- 5) Audience Favorite competition will be held throughout the pageant. You are welcome to pre-collect votes and bring money with you the day of, these are \$1.00 per vote.
  - a) **Audience Favorite competition does NOT have any deciding factor in the overall winner.**

-The judges will be appointed by the Benton County Fair Pageant. They will be persons well qualified to judge a competition of this kind. Their decision will be final. -Neither pageant coordinators, facility where it is being held, or BCFA Inc. is in no way responsible for incidents, accidents, injury or theft that may occur before, during or after the pageant.

Any contestant who fails to abide by any of the above rules or any rule/statement given orally may be disqualified from the Contest by the Pageant Director and/or Fair Management.
