Introductory Local Law No. 5 of the Town of New Lebanon for the year 2019 would amend Paragraph B of Section 16-6 of Article II of Chapter 16 of the Town of New Lebanon to read as follows:

- B. No Town officer or employee shall have an interest in any contract with the Town when such Town officer or employee, whether individually or as a member of a board, has the power or duty to negotiate, prepare, authorize or approve such contract or payment thereunder, audit bills or claims under such contract or payment thereunder, audit bills or claims under such contract or appoint an officer or employee who has any of the powers or duties set forth herein.
