Free Arts for Abused Children of New York City, Inc. ("Free Arts NYC", "we", "us", "our") are committed to maintaining the privacy of our donors both online and offline. All personal information from donors is kept confidential and will solely be used for the purpose of sending Free Arts NYC's information. We do not sell, trade, or share any information of our donors to other organizations or corporations.

Free Arts NYC website may contain links to other sites. Unless expressly stated otherwise, Free Arts NYC makes no representations whatsoever concerning the content of those sites. We caution users to make sure that they understand the associated risks before retrieving, using, relying upon, or purchasing anything via the Internet

Information We Collect And How We Use It

We collect and maintain information about you when you voluntarily provide it to us, such as when you make a donation, online or offline. This information may include your name, email address, mailing address, phone number, and employer. The information may be maintained with information about certain actions that you take, such as donation information and sign-up information. We may use the personal information that we collect to provide you with information that you have requested, contact you about events that may be of interest to you, send you newsletters or provide you with information on how to make donations. You have a choice at any time to stop us from sending you newsletters and certain updates by following the "Unsubscribe" or "Opt-Out" instructions/link provided in such emails or by sending us an email at info@freeartsnyc.org and requesting that we opt you out of such campaigns.

We store all of this information in a secure database. Every Free Arts NYC employee is background checked and any employee accessing the database has a discrete login that is frozen if and when the employee leaves.

When you make a donation online, all transaction card and financial account information processing and security is handled by third party payment processors as described in more detail in the "Donations" section below.

Donations

Certain sections of our website allow you to make donations. Online donations are handled by third-party payment processors. The third-party payment processor will handle your transaction card or financial account information, but we may obtain certain information about you, including contact data such as name, mailing address, email address; financial



data such as the last four digits of the card used in connection with the donation; and activity data such as date of donation, donation amount, and donation history. We will not share this information with third parties except in the limited circumstances described in this Privacy Policy.

Information Shared With Third Parties

We may share information with third parties if we have received your consent to do so. For example, when you indicate that you are making a donation on someone's behalf and provide us with their contact information so that we can notify them of your generosity. We may disclose your information at our sole discretion under the following circumstances:

- to comply with the law, including responding to any legal or governmental order, request or requirement, such as a subpoena;
- to protect the rights, safety and property of Free Arts NYC, our volunteers and the Public;
- to help with detecting, preventing, or resolving fraud or other security or technical issues and risks; or
- to enforce the terms of this Privacy Policy.

Emails

Free Arts NYC collects names and emails from visitors who opt-in to receiving our email newsletter. Free Arts NYC uses this information to send email communications to interested parties through MailChimp.

Do Not Track

We do not track users over time or across third-party websites to provide targeted advertising and therefore do not respond to Do Not Track ("DNT") signals.

Updating or Changing Your Personal Information
