Against the Storm Foundation's Fourth Annual Charity Golf Outing on Monday, August 30 to Benefit the Leukemia & Lymphoma Society's Western New York Pediatric Travel Assistance Fund

Proceeds to assist families and caregivers of pediatric blood cancer patients

AMHERST, N.Y., July 6, 2021 – The Against the Storm Foundation's fourth annual charity golf outing will be held Monday, August 30 at Transit Valley Country Club in East Amherst. Proceeds will benefit the Leukemia & Lymphoma Society's new Western New York Pediatric Travel Assistance Fund and other foundation-supported projects.

The travel fund was established by the Against the Storm Foundation in partnership with the Leukemia & Lymphoma Society early this year. It provides individual grants of \$500 each to qualifying families and caregivers of pediatric blood cancer patients living within a 90-mile radius of Buffalo for travel and accommodations when receiving care at Roswell Park Comprehensive Care Center, Oishei Children's Hospital of Buffalo, and other area health systems. The foundation has donated \$26,450 to the fund so far this year.

There are several ways supporters can participate in this year's event, including becoming a sponsor at levels ranging from \$1,250 to \$5,000. Foursomes are available at \$800 and individual golfers can participate at a cost of \$200. The entry fee includes golf, lunch, drinks and snacks on the course, and dinner (food stations) along with an open bar. Individual dinner/open bar tickets only (no golf) can be purchased separately for \$100.

The day's activities will also include a performance by The Kensingtons, the Sportsmen's Americana Music Foundation 2018 Band of the Year.

The schedule of events for this year's golf tournament is:

- 10:30 a.m. – Registration,
- 11:30 a.m. – Lunch and use of the driving range and practice facilities
- Noon – Shotgun start
- 5:00 p.m. – Open bar and music by The Kensingtons
- 5:30 p.m. – Dinner
