Provide a variety of products and services that we need in order to survive and thrive:

- Trees provide so much from fruit and nuts for consumption to wood to build our homes, packaging materials to transport goods, and medicines to keep us healthy.
- The economy needs people to extract these benefits from trees.



Create satisfying and rewarding jobs and career opportunities:

- California's community trees provided 60,067 jobs in 2009.<sup>1</sup>
- Trees provided \$3.3 billion in individual income to Californians.<sup>1</sup>
- Nationwide recreation services provide 6.5 million jobs.<sup>2</sup>



Add billions to our economy, keeping it moving and growing:

- In 2009, trees provided \$826 million in local, state and federal taxes.<sup>1</sup>
- California trees added \$3.6 billion to the state's economy in 2009.<sup>1</sup>
- The environmental horticulture industry provides almost \$150 billion in output, nearly 2 million jobs, and \$64 billion in labor income.<sup>3</sup>

## What Economic Benefits Do Trees and Green Spaces Provide?

 **Create Jobs** – From the skilled work of certified arborists (who plant, prune and treat trees) to entry-level jobs in nurseries and landscaping companies, urban forestry employs more than 60,000 Californians.<sup>4</sup>

 **Add Nearly \$4 Billion to California's Bottom Line** – From the manufacturing of products to the goods sold in nurseries to the salaries of workers, altogether urban forestry added nearly \$4 billion to the state's GDP in 2009.<sup>5</sup>

 **Increase business sales** – Businesses on tree-lined streets show 20% higher income streams.<sup>6</sup> More profitable businesses produce more jobs and leave fewer storefronts vacant, which helps the entire community thrive.<sup>7</sup>

 **Savings on Energy Costs** – Properly landscaping can reduce air conditioning costs by up to 50%<sup>8</sup> and home heating bills by up to 30%.<sup>9</sup> In fact, the net cooling effect of a young, healthy tree is equal to 10 room-sized air conditioners operating 20 hours/day.<sup>10</sup>



## Tree-Related Jobs

Trees provide a variety of jobs at all skill levels and income levels. From grounds crew to certified consulting arborists and much in between, there are jobs at all skill and income levels with lots of opportunity for growth.

Tree groundsmen (who assist tree trimmers with jobsite safety and operate machinery) average \$15.85/hour, while an experienced certified consulting arborist can make \$150/hour.

There are more than 50 careers options related to trees: Landscape Architect, Parks and Recreation staff, Arborist, Urban Forester, Urban Planner, Nursery staff, Groundskeeper, Environmental Educator and many more. Learn more about careers in trees at:
