Approval of Previous Minutes - Paula Conway

Minutes from the December 2018 SVS PTO meeting were reviewed and approved.

Treasurer's Report - Michelle Frankland

Treasurer's report presented and approved with an ending balance of \$16,831.50. The budget was reviewed and approved as is.

SVS Principal's Report - Kim Gallo

- Construction is proceeding on time. Framing is expected to begin in April. New parking is scheduled to be ready by the start of the 2019/20 school year.
- The AgScience program development is proceeding as planned.
- SVS received 75 applications for the AgScience program with 22 from within region 12. Initial estimates suggest 30-31 students from outside the district will be accepted into the program. Many of the prospective students have been shadowing existing SVS students.
- The 2019/20 course offerings are available online. Freshman planning meetings have been completed. Parents and students will be notified via email of upcoming meetings.
- Standardized testing has been scheduled for spring 2019. The SAT for Juniors will be held on April 9, 2019. Middle School SBACs will be held in April. Middle School NGSS (science) testing will be in May. High School NGSS testing will be in April. Parents and students will be notified of specific dates via email.
