Specifications

- Each Signature member is invited to submit up to 3 paintings online to this exhibit.
- Each signature member is guaranteed to have one painting selected for the show.
- Paintings must be:
 - entirely the work of the submitting artist. Pieces copied from others' work, from published material, or from photographs taken by another are not eligible. Also, any work done under supervision, such as a workshop or class, are not eligible.
 - at least 80% soft pastels; no oil pastels
 - created within the last three years
 - not previously been shown in any PPSCC exhibition
 - not previously been shown at the Creative Arts Center
 - not larger than 40" on longest side
 - if mat is used, it must be clean

Awards: Best in Show \$500 and 2-3 Honorable mentions (at juror's discretion)

Online Submission

Please follow the instructions carefully regarding the preparation of your images. These files will be used for a virtual exhibit as well as for jurying purposes, so please send in clearest files.

- Only jpeg image files will be accepted
- Image should be of artwork only, no frames or mats showing

- Required image size is 1500 pixels on the longest side at 300 dpi
- File submitted cannot be bigger than 2MB
- Upload your photo to computer and email your entries to jorysm@sprintmail.com
- Label your image files by capitalizing your Name and Title of your piece(s). You may abbreviate as necessary. For example: Jane_Doe_HomewardBound.jpg
- Also please include pricing in the email.
